~93-10. Registration Fees

The following non-life hazard uses shall register with the Bureau of Fire Prevention and pay an annual registration fee, according to the following schedule:

| (1) Mercantile / Retail / Banking | \$50 for the first 2,000 sq feet.
\$5 for each additional 1,000 Square feet or fraction thereof. |
| (2) Factories, Assembly Plants, Wood & Metal Shops | \$75 for the first 1,000 sq feet.
\$10 for each additional 1,000 Square feet or fraction thereof. |
| (3) Warehouse, Storage (No Assembly Manufacturing or Retailing) | \$50 for the first 3,000 sq feet.
\$5 for each additional 1,000 Square feet or fraction thereof. |
| (4) Business / Office | \$50 for the first 2,000 sq feet.
\$5 for each additional 1,000 Square feet or fraction thereof. |
| (5) Multiple Dwellings (three or more Dwelling units) | \$50 for the first four dwelling units. \$10 for each additional Four units or fraction thereof. |
| (6) Other Use: | \$50 Minimum Inspection Fee |
- B.** Residential (one or two-family houses): Annual Registration Fee is **\$40** per rental unit.
- C.** Uses not classified above that are subject to the Uniform Fire Code will be classified as business uses.
- D.** Uses required to register with the State of New Jersey, as Life Hazard Uses shall not be required to register under this section.
- E.** In the discretion of the Fire official, vacant buildings will be charged and inspected according to the previous use of the building.
