### N.J. medical marijuana law is signed by Gov. Corzine


TRENTON -- Gov. Jon Corzine tonight signed a measure making New Jersey the 14th state to legalize marijuana for medicinal purposes, part of a flurry of bills the Democrat penned in his last full day on the job.

Corzine also signed legislation requiring chain restaurants to provide nutritional information to customers, ending state control of Camden, and adding new layers of accountability to the state's higher education system.

The governor stayed out of sight in his Newark office as the Statehouse was readied for Republican Gov.-elect Chris Christie, who takes office at noon Tuesday.

"I have enormous gratitude to the people of New Jersey for this decade of opportunity to serve," said Corzine, a U.S. Senator before becoming governor. He has not revealed his future plans.

The marijuana bill (S119) is expected to take effect in six months. Only patients with specific illnesses would be permitted to get a prescription: cancer, glaucoma, multiple sclerosis, HIV/AIDS, seizure disorder, amyotrophic lateral sclerosis (also known as Lou Gherig's disease), severe muscle


New Jersey residents will decide whether to legalize marijuana in the Garden State, after both houses of the state Legislature voted Monday to put the question on the 2020 ballot.

The measure passed the state Senate in a 24-16 vote at the Statehouse in Trenton on Monday afternoon, while the state Assembly voted 49-24 with one abstention.

"People actually smoke marijuana every day," said state Sen. Nicholas Scutari, D-Union, a sponsor of the proposal. "Can you believe it? But until your relative gets arrested over this substance that is widely used in this state and country" some people will not understanding why this is so important.

Gov. Phil Murphy made legalizing marijuana for those over 21 one of his campaign promises. In the nearly two years since he took office, the initiative has seen several setbacks. State Senate President Stephen Sweeney announced in late

### NJ Legislature, Gov. Murphy Reach Agreement on Marijuana Legalization

New Jersey voters passed legalizing weed on Election Day, with lawmakers hashing out the ins and outs of legislation for the past month; a vote on the final deal is scheduled for Dec. 17

A bill legalizing marijuana in New Jersey could soon be puff, puff, passed after the state legislature and Gov. Phil Murphy came to an agreement late Friday.

The governor announced a deal had been reached on Twitter, saying that a framework for the legalization was in place. He went on to say that making marijuana legal in the state is a "critical step in reducing racial disparities and social inequities that have long plagues our criminal justice system."

There are still two bills that must be voted on, according to State Sen. Nicholas Scutari. A decriminalization bill would have all pending possession charges dropped, Scutaro said, with adults allowed to carry up to six ounces without facing charges. Previous legislation has included past convictions as eligible for expungement.

There is also a bill regarding the sale of weed, which was a key difference between state Senate and Assembly bills in November. There will be a cap of 37 cultivators being issued licenses, but those sellers will be allowed as many outlets as desired as long as they are approved by the town, according to Scutari. After two years, the cap on cultivators will end, opening the market further.

The state's 6.625 percent sales tax would also apply, 70 percent of which will go to a social equity fund. The remaining amount will go to police training for marijuana DUIs, and to running the program itself, Scutari said. An extra social equity tax will eventually kick in as well, with all revenue generated in the fun going to impact zones where populations have suffered the most from possession enforcement.

# **Consumption Laws**

- No smoking or using cannabis in public similar to public alcohol consumption

# AN ORDINANCE BY THE BOROUGH OF METUCHEN IN THE COUNTY OF MIDDLESEX, NEW JERSEY PROHIBITING THE OPERATION OF ANY CLASS OF CANNABIS BUSINESSES WITHIN ITS GEOGRAPHICAL BOUNDARIES AND AMENDING SECTION 110-93 OF THE METUCHEN CODE

WHEREAS, the Borough of Metuchen is supportive of the concept of the sale and distribution of cannabis but requires time for state regulation to be finalized; and

WHEREAS, in 2020 New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults at least 21 years of age: and

WHEREAS, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults 21 gears of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and

WHEREAS, as set forth in more detail below, the Act requires that any municipal prohibition by the Borough of Metuchen must be adopted within 180 days of the effective date of the Act (i.e., by August 21, 2021), and that the failure to timely act shall mean that for a period of five years thereafter, the growing, cultivating, manufacturing, selling and reselling of cannabis items shall automatically be permitted uses in all industrial zones, and the retail zones; and

WHEREAS, the Act does not preclude a municipality from prohibiting cannabis establishments and operations within its municipal limits within the 180 days of the effective date of the Act and thereafter authorizing and/or permitting any one or more of the cannabis establishments (defined in section 3 of the Act as "a cannabis cultivator, a cannabis wholesaler, or a cannabis retailer") within the municipality; and

WHEREAS, the State's newly created Cannabis Regulatory Commission is charged with adopting rules including those for licensing applications and eligibility; the number of permissible licenses of each type; security requirements for licensees; labeling and packaging

Borough of Metuchen County of Middlesex State of New Jersey

AN ORDINANCE BY THE BOROUGH OF METUCHEN IN THE COUNTY OF MIDDLESEX, NEW JERSEY CONDITIONALLY PERMITTING CLASS 3 CANNABIS WITHIN CERTAIN MIDDLESSES AND CLASS 5 CANNABIS RETAIL BUSINESSES WITHIN CERTAIN ZONING DISTRICTS, ESTABLISHING LICENSING, AND OTHER CLASSES OF CANNABIS REPORE AND CONTINUING TO PROHIBIT ALL METUCHEN METUCHEN

WHEREAS, in 2020 New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults at least 21 years of age; and

WHEREAS, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults 21 commercial recreational (adult use) cannabis operations, use and possession; and


WHEREAS, the Act required that any municipal prohibition by the Borough of Metuchen must be adopted within 180 days of the effective date of the Act (i.e., by August 21, 2021), and that the failure to timely act shall mean that for a period of five years thereafter, the automatically be permitted uses in all industrial zones, and the retail selling of cannabis items shall consumers shall be a conditional use in all commercial and retail zones; and

WHEREAS, the Act did not preclude a municipality from prohibiting cannabis date of the Act and thereafter authorizing and/or permitting any one or more of the cannabis establishments (defined in section 3 of the Act as "a cannabis cultivator, a cannabis manufacturer, a cannabis wholesaler, or a cannabis retailer") within the municipality; and

WHEREAS, the State's newly created Cannabis Regulatory Commission ("CRC") was charged with adopting rules including those for licensing applications and eligibility; the number of permissible licenses of each type; security requirements for licensees; labeling and packaging and packaging and marketing limitations;

• Class 1 - Cultivator
Grow recreational use cannabis

• Class 3 - Wholesaler
Store, sell or otherwise transfer, recreational use cannabis items between cannabis cultivators, wholesalers, or retailers

Class 5 - Retail
 Purchase recreational use cannabis from licensed cultivators, manufacturers, or wholesalers and sell those items to consumers in a retail store

• Class 2 - Manufacturer

Produce recreational use cannabis

Class 4 - Distributor
 Transport cannabis items in bulk between cannabis cultivators, manufacturers, or retailers within the state of New Jersey

Class 6 - Deliver

Transport a consumer's purchases of recreational use cannabis and related supplies from the retailer to that consumer



## Licenses Available & Fees

- 2 Wholesaler
- 3 Retail
- \$2,500 Application Fee
- \$15,000 Annual License Fee

# Zoning

- Class 3 (wholesale) in the north west Light Industrial zone
- Retail allowed in our "highway" retail zones
- No Class 5 (retail) on Main Street
- All cannabis businesses are a conditional use



### **Taxation**

- Class 3 Cannabis Wholesalers: One percent (1%) of receipts from each sale
- Class 5 Cannabis Retailers: Two percent (2%) of the receipts from each sale

# **Conditions & Limitations**

- Hours of operation are between 9am and 10pm
- Queuing of customers outside a cannabis facility is prohibited
- Not within 200 feet of a K-12 school
- No cannabis product or paraphernalia shall be visible from outside
- No on site consumption
- Limitation on noise and odor
