The Regular Meeting of the Borough Council was held in the Council Chambers of Borough Hall on Monday, July 18, 2022.

The Meeting was called to order at 7:30 p.m. by Council President Delia.

# **Public Comment**

Council President Delia opened Public Comment to any members of the public wishing to speak.

Allison Inserro, 194 Woodbridge Avenue, spoke regarding the proposed power plant in the Keasbey section of Woodbridge. Ms. Inserro noted that, while the Mayor had said that Council is not in favor of passing the kind of resolutions that are public statements of support and have no force of law, there has been some precedent of Council doing so. Ms. Inserro pointed out research regarding the effects of climate change and its effect on health, and asked that Council pass a resolution opposing the proposed power plant.

John Hsu, 219 West Shirley Avenue, Edison, asked about the status of Council passing a resolution opposing the construction of the power plant in the Keasbey section of Woodbridge.

Seeing no one else wishing to speak, Council President Delia closed the Public Comment.

# **ORDINANCE 2022-14**

Borough of Metuchen County of Middlesex State of New Jersey

# ORDINANCE AMENDING § 185-14 OF THE CODE OF THE BOROUGH OF METUCHEN TO PROHIBIT PARKING UPON A PORTION OF GREEN STREET IN THE BOROUGH OF METUCHEN

**WHEREAS**, Chapter 185 of the Code of the Borough of Metuchen regulates vehicles, traffic and parking withing the Borough of Metuchen; and

**WHEREAS**, § 185-14 of the Code of the Borough of Metuchen specifically designates the locations wherein parking is prohibited at any time within the Borough; and

**WHEREAS**, the Chief of Police and the Borough Engineer have investigated, determined and recommends to the Mayor and Borough Council that it is in the best interest of the safety and welfare of its residents, and the community in general, to prohibit parking on both sides of Green Street from the Middlesex Greenway proceeding twenty-five (25) feet north up to the driveway of the Green Street Apartment Complex; and

WHEREAS, the Council of the Borough of Metuchen have determined to accept the recommendation of the Chief of Police and Borough Engineer finding that that it is in the best

interest of the safety and welfare of its residents and the community in general to prohibit parking on both sides of Green Street from the Middlesex Greenway proceeding twenty-five (25) feet north up to the driveway of the Green Street Apartment Complex and to amend the Borough Code accordingly.

**NOW THEREFRORE BE IT ORDAINED** by the Council of the Borough of Metuchen, County of Middlesex that it hereby amends § 185-14 of the Code of the Borough of Metuchen to include the following location:

# § 185-14 Parking prohibited at all times on certain streets.

No person shall park a vehicle at any time upon any streets or parts thereof described.

Name of Street	Side	Location
Green Street	Both	From the Middlesex Greenway proceeding twenty- five (25) feet north up to the driveway entrance to the Green Street Apartment Complex

**BE IT FURTHER ORDAINED** by the Mayor and Council that all remaining locations contained in the Table in §185-14 shall remain locations wherein parking is prohibited and shall not be affected by the within amendments and shall remain in full force and effect.

**BE IT FURTHER ORDAINED** that should any section, paragraph, sentence, clause, or phase of this ordinance be declared unconstitutional or invalid for any reason, the remaining portion of this ordinance shall not be affected thereby and shall remain in full force and effect, and to that end the provisions of this ordinance are hereby declared to be severable; and

**BE IT FURTHER ORDAINED** that all ordinances or parts of ordinances inconsistent with this amending ordinance are hereby repealed to the extent of their inconsistencies only; and

**BE IT FURTHER ORDAINED** that this ordinance shall be in full force and take effect after final passage and publication, as required by law.

**BE IT FURTHER ORDAINED** by the Mayor and Borough Council of the Borough of Metuchen that all Borough officials and employees shall take all necessary actions to in order to effectuate and enforce the within Ordinance, including but not limited to the installation of sign/s in the above designated area.

**WHEREAS** five (5) bids were received by the Borough Civil Engineer – With Specialization in Wastewater Engineering, Qualified Purchasing Agent, Director of Special Projects, and Borough Administrator on or before June 22, 2022, for the Jersey Avenue Pump Station Replacement for the Borough of Metuchen – Shared Services Project with the Township of Edison: and

**WHEREAS,** the Borough Council has reviewed the letter of recommendation made by the Borough Engineer on said bid, dated June 29, 2022; and

**WHEREAS** the maximum amount of award for the Jersey Avenue Pump Station Replacement is \$6,989,835.00. Funds are available in the 2020-04/2021-06/2022-06 Capital Bond Ordinance as certified by the Chief Finance Officer. **BE IT FURTHER RESOLVED** that the Mayor and the Borough Clerk are hereby authorized and directed to execute the contract for the same, and

# **RESOLUTION 2022-167**

RESOLUTION OF THE BOROUGH OF METUCHEN, IN THE COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, DETERMINING THE FORM AND OTHER DETAILS OF ITS "NOTE RELATING TO THE WATER BANK CONSTRUCTION FINANCING PROGRAM OF THE NEW JERSEY INFRASTRUCTURE BANK", TO BE ISSUED IN THE PRINCIPAL AMOUNT OF UP TO \$8,600,000, AND PROVIDING FOR THE ISSUANCE AND SALE OF SUCH NOTE TO THE NEW JERSEY INFRASTRUCTURE BANK, AND AUTHORIZING THE EXECUTION AND DELIVERY OF SUCH NOTE BY THE BOROUGH OF METUCHEN IN FAVOR OF THE NEW JERSEY INFRASTRUCTURE BANK, ALL PURSUANT TO THE WATER BANK CONSTRUCTION FINANCING PROGRAM OF THE NEW JERSEY INFRASTRUCTURE BANK AND CANCELING AND REPEALING RESOLUTION NUMBER 2021-142

WHEREAS, the Borough of Metuchen (the "Local Unit"), in the County of Middlesex, State of New Jersey, has determined that there exists a need within the Local Unit to acquire, construct, renovate or install a project consisting of the construction of a new Pump Station (the "Project"), and it is the desire of the Local Unit to obtain financing for such Project through participation in the environmental infrastructure financing program (the "New Jersey Water Bank") of the New Jersey Infrastructure Bank (the "I-Bank");

WHEREAS, the Local Unit has determined to temporarily finance the acquisition, construction, renovation or installation of the Project prior to the closing with respect to the New Jersey Water Bank, and to undertake such temporary financing with the proceeds of a short-term loan to be made by the I-Bank (the "Construction Loan") to the Local Unit, pursuant to the Water Bank Construction Financing Program of the I-Bank (the "Construction Financing Program");

WHEREAS, in order to (i) evidence and secure the repayment obligation of the Local Unit to the I-Bank with respect to the Construction Loan and (ii) satisfy the requirements of the Construction Financing Program, it is the desire of the Local Unit to issue and sell to the I-Bank the "Note Relating to the Water Bank Construction Financing Program of the New Jersey Infrastructure Bank" in an aggregate principal amount of up to \$8,600,000 (the "Note");

**WHEREAS,** it is the desire of the Local Unit to authorize, execute, attest and deliver the Note to the I-Bank pursuant to the terms of the Local Bond Law of the State of New Jersey, constituting Chapter 2 of Title 40A of the Revised Statutes of the State of New Jersey (the "Local Bond Law"), and other applicable law; and

**WHEREAS**, Section 28 of the Local Bond Law allows for the sale of the Note to the I-Bank, without any public offering, and N.J.S.A. 58:11B-9 allows for the sale of the Note to the I-Bank without any public offering, all under the terms and conditions set forth therein; and

**WHEREAS,** it is also the desire of the Local Unit to cancel and repeal Resolution Number 2021-142 duly adopted by the Borough Council of the Local Unit on May 10, 2021.

**NOW, THEREFORE, BE IT RESOLVED** by the governing body of the Local Unit as follows:

Section 1. In accordance with Section 28 of the Local Bond Law and N.J.S.A. 58:11B-9, the Local Unit hereby authorizes the issuance, sale and award of the Note in accordance with the provisions hereof. The obligation represented by the Note has been appropriated and authorized by (i) bond ordinance number 2020-04 of the Local Unit, which bond ordinance is entitled "BOND ORDINANCE PROVIDING FOR THE CONSTRUCTION OF A NEW PUMP STATION, BY AND IN THE BOROUGH OF METUCHEN, IN THE COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, APPROPRIATING \$4,100,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$4,100,000 BONDS OR NOTES TO FINANCE THE COST THEREOF" finally adopted by the Local Unit at a meeting duly called and held on February 3, 2020, as amended and supplemented by bond ordinance number 2021-06 of the Local Unit, finally adopted by the Local Unit at a meeting duly called and held on March 22, 2021, and as further amended and supplemented by bond ordinance number 2022-06 of the Local Unit, finally adopted by the Local Unit at a meeting duly called and held on May 9, 2022, at which meetings quorums were present and acted throughout, all pursuant to the terms of the Local Bond Law and other applicable law.

**Section 2.** The Chief Financial Officer of the Local Unit (the "Chief Financial Officer") is hereby authorized to determine, in accordance with the Local Bond Law and pursuant to the terms and conditions hereof, (i) the final principal amount of the Note (subject to the maximum limitation set forth in Section 4(a) hereof), and (ii) the dated date of the Note.

**Section 3.** Any determination made by the Chief Financial Officer pursuant to the terms hereof shall be conclusively evidenced by the execution and attestation of the Note by the parties authorized pursuant to Section 4(h) hereof.

**Section 4.** The Local Unit hereby determines that certain terms of the Note shall be as follows:

- (a) the principal amount of the Note to be issued shall be an amount up to \$8,600,000;
- (b) the maturity of the Note shall be as determined by the I-Bank;
- (c) the interest rate of the Note shall be as determined by the I-Bank;
- (d) the purchase price for the Note shall be par;
- (e) the Note shall be subject to prepayment prior to its stated maturity in accordance with the terms and conditions of the Note;
- (f) the Note shall be issued in a single denomination and shall be numbered "NJWB-CFP-2022-01";
- (g) the Note shall be issued in fully registered form and shall be payable to the registered owner thereof as to both principal and interest in lawful money of the United States of America; and
- (h) the Note shall be executed by the manual or facsimile signatures of the Mayor and the Chief Financial Officer under official seal or facsimile thereof affixed, imprinted, or reproduced thereon and attested by the manual signature of the Local

Unit Clerk or Acting Clerk.

- **Section 5.** The Note shall be substantially in the form attached hereto as Exhibit A.
- **Section 6.** The law firm of Wilentz, Goldman & Spitzer, P.A. is hereby authorized to arrange for the printing of the Note, which law firm may authorize McCarter & English, LLP, bond counsel to the I-Bank for the Construction Financing Program, to arrange for same.
- **Section 7.** The Authorized Officers of the Local Unit are hereby further severally authorized to (i) execute and deliver, and the Local Unit Clerk or Acting Clerk is hereby further authorized to attest to such execution and to affix the corporate seal of the Local Unit to, any document, instrument or closing certificate deemed necessary, desirable or convenient by the Authorized Officers or the Clerk of the Local Unit, as applicable, in their respective sole discretion, after consultation with counsel and any advisors to the Local Unit and after further consultation with the I-Bank and its representatives, agents, counsel and advisors, to be executed in connection with the issuance and sale of the Note and the participation of the Local Unit in the Construction Financing Program, which determination shall be conclusively evidenced by the execution of each such certificate or other document by the party authorized hereunder to execute such certificate or other document, and (ii) perform such other actions as the Authorized Officers deem necessary, desirable or convenient in relation to the execution and delivery of the Note and the participation of the Local Unit in the Construction Financing Program.
- **Section 8.** Resolution Number 2021-142 is hereby canceled and repealed in its entirety.
  - **Section 9.** This resolution shall take effect immediately.
- **Section 10.** Upon the adoption hereof, the Local Unit Clerk or Acting Clerk shall forward certified copies of this resolution to Wilentz, Goldman & Spitzer, P.A., bond counsel to the Local Unit, David E. Zimmer, Executive Director of the I-Bank, and Richard T. Nolan, Esq., McCarter & English, LLP, bond counsel to the I-Bank.

# **RESOLUTION 2022-168**

# RESOLUTION APPOINTING CONDITIONAL REDEVELOPER AND AUTHORIZING EXECUTION OF A MEMORANDUM OF UNDERSTANDING

**WHEREAS**, the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40A:12A-1, <u>et seq.</u>, as amended and supplemented (the "<u>Redevelopment Law</u>"), provides a process for municipalities to participate in the redevelopment and improvement of areas in need of rehabilitation or redevelopment; and

**WHEREAS**, the Borough, pursuant to the Redevelopment Law, via Resolution #2020-50, adopted on February 3, 2020, by the Mayor and Council of the Borough of Metuchen (the "Borough Council"), designated the entirety of the Borough of Metuchen (the "Borough"), as an "Area in Need of Rehabilitation"; and

**WHEREAS**, in order to facilitate the rehabilitation and redevelopment of the Borough, including the property known as Block 130.01, Lots 47.01, 47.02, 48 and 60.01 (the "<u>Property</u>"), the Borough Council adopted Ordnance #2020-10 on May 26, 2020, which adopted a redevelopment plan for the entirety of the Borough entitled "Redevelopment Plan for Rehabilitation in the Borough of Metuchen" dated March 2020 (the "<u>Redevelopment Plan</u>"); and

**WHEREAS**, the Borough has been in discussions with Suburban Sportsland, LLC, (the "Conditional Redeveloper") regarding the rehabilitation and redevelopment of the Property; and

**WHEREAS**, N.J.S.A. 40A:12A-8(f) authorizes the Borough to arrange or contract with a Redeveloper for the undertaking of any project or redevelopment work in an area designated as in need of rehabilitation or redevelopment; and

**WHEREAS**, Conditional Redeveloper has presented its redevelopment concepts to the Borough; and

**WHEREAS**, the Borough and Conditional Redeveloper intend to commence exclusive negotiations toward the formulation of a Redevelopment Agreement to develop the Property in accordance with the requirements of the Redevelopment Plan; and

**WHEREAS**, in such event, the Borough desires to designate Suburban Sportsland, LLC, as Conditional Redeveloper in order to negotiate with Conditional Redeveloper for a period of one hundred and eighty (180) days in an effort to agree upon a Redevelopment Agreement; and

**WHEREAS**, the Borough and Conditional Redeveloper desire to memorialize, in writing, their agreement under a non-binding Memorandum of Understanding that evidences the statement of intent of both the Borough and Conditional Redeveloper.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Metuchen, County of Middlesex, State of New Jersey that:

- 1. The aforementioned recitals are incorporated herein as though fully set forth at length.
- 2. Suburban Sportsland, LLC, is hereby designated as Conditional Redeveloper for the Property and the Mayor and Borough Clerk are hereby authorized to execute a Memorandum of Understanding between the Borough and Conditional Redeveloper evidencing the parties' agreement to conduct exclusive negotiations toward the formulation of a Redevelopment Agreement for the Property.
- 3. This Resolution shall take effect immediately.

# **RESOLUTION 2022-169**

# RESOLUTION ACCEPTING THE GOVERNOR'S COUNCIL ON ALCOHOLISM AND DRUG ABUSE DMHAS YOUTH LEADERSHIP GRANT

**NOW THEREFORE BE IT RESOLVED,** by the Borough of Metuchen, County of Middlesex, State of New Jersey that the Borough recognizes the following:
