ORDINANCE 2023-05

Borough of Metuchen County of Middlesex State of New Jersey

ORDINANCE AMENDING CHAPTER 137 OF THE CODE OF THE BOROUGH OF METUCHEN, ENTITLED, "PRECIOUS METALS AND GEMS" TO ADD SECONDHAND GOODS AND TO REQUIRE ADDITIONAL RECORDKEEPING AND REPORTING

WHEREAS, at the recommendation of the Chief of Police, the Mayor and Council have determined that it is in the best interest of the residents of the Borough of Metuchen to assist law enforcement officials and victims of crime in recovering stolen precious metals, gems and other secondhand goods and to require minimum identification, reporting, maintenance and distribution criteria for dealers in these types goods.

NOW THEREFORE BE IT ORDAINED by the Council of the Borough of Metuchen, County of Middlesex, that it hereby amends Chapter 137, entitled, "Precious Metals and Gems" of the Code of the Borough of Metuchen, to "Precious Metals, Gems and Secondhand Goods", to state as follows:

CHAPTER 137

PRECIOUS METALS, AND GEMS AND SECONDHAND GOODS

§ 137-1.- Purpose and Intent

- A. The purpose and intent of this chapter is to assist law enforcement officials and victims of crime in recovering stolen precious metals, gems and other secondhand goods by reporting minimum identification, reporting, maintenance and distribution criteria for dealers in these goods.
- B. No person shall use, exercise, or carry on the business, trade, or occupation of the buying and selling, or pawning of precious metals, gems or other secondhand goods without complying with the requirements of this Chapter in the exact manner described.

§ 137-2. Definitions

As used in this Chapter, the following terms shall have the meaning indicated:

ACCEPTABLE IDENTIFICATION

A current valid New Jersey driver's license or identification card, a current valid photo driver's license issued by another U.S. state, a valid United States passport, or other verifiable U.S. government-issued identification, which will be recorded on the receipt

DEALER

Any person, partnership, limited liability company, corporation, or other entity who either wholly or in part, engages in or operates any of the following trades or businesses: the buying for purposes of resale of precious metals, jewelry, or other secondhand goods as defined herein; pawnbrokers as defined herein; itinerant businesses as defined herein. For the purposes of this chapter, transient buyers, as defined herein, are subject to the same licensing and reporting requirements as any other dealers.

ITINERANT BUSINESS

A dealer who conducts business intermittently within the Borough or at varying locations.

PAWNBROKER

Any person, partnership, association or corporation: lending money on deposit or pledges of personal property, other than choses in action, securities, or printed evidences of indebtedness; purchasing personal property on condition of selling it back at a stipulated price; or doing business as furniture storage warehousemen and lending money on goods, wares or merchandise pledged or deposited as collateral security.

PRECIOUS METALS

Gold, silver, platinum, palladium, and their alloys as defined in N.J.S.A. 51:5-1 et seq. and N.J.S.A. 51:6-1 et seq.

PUBLIC

<u>Individuals</u> and retail sellers, not to include wholesale transactions or transactions between other merchants.

REPORTABLE TRANSACTION

Every transaction conducted between a dealer and a member of the public in which precious metals, jewelry, or any other secondhand goods as defined herein are purchased or pawned.

SECONDHAND GOODS

Used goods such as antiques, gold, silver, platinum, or other precious metals, jewelry, coins, gemstones, gift cards, any tools, telephones, typewriters, word processors, GPS devices, computers, computer hardware and software, television sets, radios, record or stereo sets, electronic devices, musical instruments, sporting goods, automotive equipment, collectibles, game cartridges, DVDs, CDs, and other electronically recorded material, firearms, cameras and camera equipment, video equipment, furniture, clothing,

- A. Judicial sales or sales by executors or administrators;
- B. Occasional or auction sales of household goods sold from private homes;
- C. Auctions of real estate;

D. The occasional sale, purchase, or exchange of coins or stamps by a personat his permanent residence or in any municipally owned building who is engaged in the hobby of collecting coins or stamps and who does not solicit the sale, purchase, or exchange of such coins or stamps to or from the general public by billboard, sign, handbill, newspaper, magazine, radio, television, or other form of printed or electronic advertising.

§ 137-3. Written record of reportable transactionspurchases.

Any person, partnership or corporation in the full- or part-time business of purchasing gold, silver, precious metals—and, gems and other secondhand goods in the Borough of Metuchen shall maintain a written record of all reportable transactionspurchases.

§ 137-<u>42</u>. Form of record.

Said record shall be contained in a book bound with stitching, glue or other type of permanent binding and shall not be contained in any loose-leaf, spiral, insert or other type of semipermanent or temporary binding. There shall be no spaces between entries, and each entry shall be numbered in sequence. § 137-3. Data required for record—Said record shall be legible and contain the following information:

- A. Date of sale.
- B. Name and address of seller.
- C. Detailed description of items purchased.
- D. Purchase price.

§ 137-53. <u>Identification of Seller; Recordkeeping requirements</u> Data required foregreen.

- A. Require of each person selling or pawning precious metals or other secondhand goods acceptable identification as defined above in § 137-2.
- B. Require each seller to execute a declaration of ownership, which shall contain the following certification: "My signature confirms that I am the sole legal owner of and am legally authorized to sell the goods being sold. By signing below I certify that I did not obtain and do not possess the identified goods through unlawful means. I am the full age of 18 years and the identification presented is valid and correct."
- C. Record and issue to each person selling or pawning such goods on a sequentially numbered receipt:
 - (1) The name, address, and telephone number of the purchaser, including the clerk or employee of the dealer making the purchase;
 - (2) The name, address, date of birth, and telephone number of the seller or sellers;
 - (3) A photographed recording of the seller in a format acceptable to the Chief of Police, along with a physical description of the seller, including height and weight (approximate), hair color, eye color, facial hair, if any, etc.;
 - (4) A photographed recording of the seller's presented acceptable identification, as set forth in § 137-2, in a format acceptable by the Chief of Police;
 - (5) A photographed recording of all items sold in a format acceptable by the Chief of Police. When photographing, all items must be positioned in a manner that makes them readily and easily identifiable. Items should not be grouped together when photographing or imaging. Each item should have its own photograph;
 - (6) The receipt number;
 - (7) A detailed, legible description of the item(s) and the manufacturer and model of the item(s) if known; in the case of jewelry, the descriptions must include style, length, color, design, and stones, if any; any identifying marks, including numbers, dates, sizes, shapes, initials, names, monograms, social security numbers engraved thereon, serial numbers, series numbers, or any other information, which sets apart the particular object from others of like kind;
 - (8) The price paid for the purchase or pawn of the item(s);

(9) If precious metals, the net weight in terms of pounds Troy, pennyweight (Troy) or kilograms/grams; fineness in terms of karats for gold, and sterling or coin for silver, in accordance with N.J.S.A. 51:5-1, N.J.S.A. 51:6-1 et seq.;

(10) The time and date of the transaction.

§ 137-64. Identity of seller Reports to the Police Department.

The information contained in § 137-5 shall be electronically submitted to the Borough of Metuchen Police Department Detective Bureau within seventy-two (72) hours of the transaction in the form and as required and provided for by the Chief of Police.

§ 137-75. Availability of record.

The <u>dealerpurchaser</u> shall make the record<u>s</u> required by this <u>Chapter</u> available for inspection of any law enforcement officer, upon demand, without the need for advance notice. The record<u>s</u> required by this <u>Chapter</u> shall be kept at the <u>Dealerpurchaser</u>'s business premises. <u>In addition to all other reporting requirements</u>, every dealer shall maintain for at least five years a written record of all purchases of precious metals, gems and other secondhand goods in the form prescribed in § 137-5(C).

§ 137-86. Retention and Inspections.

All secondhand goods purchased, received for pawn, or received for consignment as described above are to be made available for inspection by the Chief of Police or designee thereof at the designated business address for a period of at least seven (7) calendar days from the date the transaction information is actually reported to the Chief of Police in the approved manner described above in § 137-6 except for precious metals and jewelry, which must be maintained for at least ten (10) business days or for the statutory period provided in N.J.S.A. 2C:21-36(d).

(1) All precious metal or other secondhand goods subject to inspection musteremain in the same condition as when purchased or received for pawn and shall not be sold, disposed of, changed, modified, or melted by the dealer until the retention period has expired. Itinerant businesses and transient buyers will be responsible for notifying the Chief of Police of the location where the purchased item(s) are being held Each purchaser doing business in the Borough shall deliver to the Chief of Police the description of all items purchased or received within 72 hours of the completion of the transaction, on forms prescribed by the Chief of police.

§ 137-97. Prohibitions.

No <u>dealerpurchaser</u> shall sell, melt, change the form or dispose of any articles purchased or received for a period of <u>ten (10)</u> days from the date the notification is made to the Chief of Police. All such items shall remain on the premises where the purchase was made until the expiration of the time period set forth herein.

§ 137-108. Violations and penalties.

Any person who shall violate any provision of §§ 137-1 through 137-97 of this chapter or shall fail to comply with any of the requirements thereof shall, upon conviction thereof, be punished as provided in Chapter 1, General Provisions, Article 1. A separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

BE IT FURTHER ORDAINED by the Mayor and Council that all prior ordinances, or sections of ordinances, inconsistent with the within ordinance are hereby repealed; and

BE IT FURTHER ORDAINED by the Mayor and Council that all remaining sections of the Code not amended or referenced herein shall not be affected thereby and shall remain in full force and effect; and

BE IT FURTHER ORDAINED by the Mayor and Council that if any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall continue in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable; and

BE IT FURTHER ORDAINED by the Mayor and Council that this ordinance shall become effective immediately upon final passage and publication as provided by law.

BOND ORDINANCE 2023-06

Borough of Metuchen County of Middlesex State of New Jersey

BOND ORDINANCE APPROPRIATING \$4,700,000 AND AUTHORIZING \$2,571,000 BONDS OR NOTES OF THE BOROUGH FOR IMPROVEMENTS TO EDGAR FIELD AUTHORIZED TO BE UNDERTAKEN BY THE BOROUGH OF METUCHEN, IN THE COUNTY OF MIDDLESEX, NEW JERSEY

BE IT ORDAINED BY THE BOROUGH OF METUCHEN, IN THE COUNTY OF

MIDDLESEX, NEW JERSEY (not less than two-thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

Section 1. The improvements described in Section 3 of this bond ordinance are hereby respectively authorized as general improvements to be made or acquired by the Borough of Metuchen, New Jersey (the "Borough"). For the said improvements or purposes stated in said Section 3, there is hereby appropriated the sum of \$4,700,000, said sum being inclusive of all appropriations heretofore made therefor and including (i) the sum of \$129,000 as the down payment for said improvements or purposes required by law and more particularly described in said Section 3 and now available therefor by virtue of provision in a previously adopted budget or budgets of the Borough for down payment or for capital improvement purposes and (ii) a grant from the New Jersey Department of Education in the amount of \$2,000,000 (the "Grant").

Section 2. For the financing of said improvements or purposes and to meet the part of said \$4,700,000 appropriation not provided for by application hereunder of said down payment and the Grant, negotiable bonds of the Borough are hereby authorized to be issued in the principal amount of \$2,571,000 pursuant to the Local Bond Law of New Jersey, constituting Chapter 2 of Title 40A of the New Jersey Statutes (the "Local Bond Law"). In anticipation of the issuance of said bonds

and to temporarily finance said improvements or purposes, negotiable notes of the Borough in a principal amount not exceeding \$2,571,000 are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

- (b) The average period of usefulness of said purposes, within the limitations of the Local Bond Law and taking into consideration the respective amounts of said obligations authorized for the purposes, according to the reasonable life thereof computed from the date of the bonds authorized by this bond ordinance, is 15 years.
- (c) The supplemental debt statement required by the Local Bond Law has been duly made and filed in the office of the Borough Clerk and a complete copy thereof has been

electronically filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey, and such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided for in this bond ordinance by \$2,571,000, and the said obligations authorized by this bond ordinance will be within all debt limitations prescribed by the Local Bond Law.

(d) Amounts not exceeding \$600,000 in the aggregate for interest on said obligations, costs of issuing said obligations, engineering costs and other items of expense listed in and permitted under Section 40A:2-20 of the Local Bond Law are included as part of the estimated costs of said improvements.

Section 5. Any funds from time to time received by the Borough as grants in aid of financing the improvements or purposes described in Section 3 of this bond ordinance, including without limitation the Grant, shall be used for financing said improvements or purposes by application thereof either to direct payment of the costs of said improvements or purposes, or to payment or reduction of the authorization of the obligations of the Borough authorized therefor by this bond ordinance. Any such funds so received may, and all such funds so received which are not required for direct payment of the costs of said improvements or purposes shall, be held and applied by the Borough as funds applicable only to the payment of obligations of the Borough authorized by this bond ordinance.

Section 6. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and interest on the obligations authorized by this bond ordinance. BOND ORDINANCE 2023-07

Borough of Metuchen County of Middlesex State of New Jersey

BOND ORDINANCE APPROPRIATING \$2,913,615 AND AUTHORIZING \$2,355,000 BONDS OR NOTES OF THE BOROUGH FOR VARIOUS IMPROVEMENTS AND PURPOSES AUTHORIZED TO BE UNDERTAKEN BY THE BOROUGH OF METUCHEN, IN THE COUNTY OF MIDDLESEX, NEW JERSEY

BE IT ORDAINED BY THE BOROUGH OF METUCHEN, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

Section 1. The improvements described in Section 3 of this bond ordinance are hereby respectively authorized as general improvements to be made or acquired by the Borough of Metuchen, New Jersey (the "Borough"). For the said improvements or purposes stated in said Section 3, there is hereby appropriated the sum of \$2,913,615, said sum being inclusive of all appropriations heretofore made therefor and including (i) the sum of \$125,000 as the down payment for said improvements or purposes required by law and more particularly described in said Section 3 and now available therefor by virtue of provision in a previously adopted budget or budgets of the Borough for down payment or for capital improvement purposes and (ii) a grant from the New Jersey Department of Transportation in the amount of \$433,615 (the "Grant").

- (b) The estimated maximum amount of bonds or notes to be issued for said purposes is \$2,355,000.
 - (c) The estimated cost of said purposes is \$2,913,615, which represents the initial

appropriation made by the Borough. The excess of the appropriation of \$2,913,615 over the estimated maximum amount of bonds or notes to be issued therefor is the amount of the Grant and the down payment for said purposes.

Section 4. The following matters are hereby determined, declared, recited, and stated:

- (a) The said purposes described in Section 3 of this bond ordinance are not current expenses and are properties or improvements which the Borough may lawfully acquire or make as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.

ORDINANCE 2023-08

Borough of Metuchen County of Middlesex State of New Jersey

ORDINANCE AMENDING CHAPTER 10, ENTITLED "COMMISSIONS AND COMMITTEES" RESTRUCTURING THE "MUNICIPAL ALLIANCE BOARD – YOUTH SERVICE BOARD" TO BECOME THE COMMUNITY ACTION FOR RECOVERY, EDUCATION, AND SUPPORT ("CARES") COMMITTEE

WHEREAS, Article 10, of Chapter 10 of the Code of the Borough of Metuchen established a Municipal Alliance – Youth Service Board and provided for the appointments of its members and the powers and duties of the Board; and

WHEREAS, the Mayor and Council of the Borough of Metuchen have determined that it is in the best interest of the Borough to prevent and reduce substance abuse and behavioral addictions and to promote mental wellness in the Borough by raising awareness and providing education focused on prevention and recovery; and

WHEREAS, the Mayor and Council of the Borough of Metuchen have determined that it is in the best interest of the Borough to restructure the Municipal Alliance Board – Youth Service Board and to create the Community Action Recovery, Education and Support Committee to operate in its stead.

NOW THEREFOR BE IT ORDAINED by the Council of the Borough of Metuchen that it hereby amends Chapter 10, Article 10 of the Code of the Borough of Metuchen to state as follows:

Article 10. Community Action for Recovery, Education and Support ("CARES") Committee

§ 10-35. Establishment; Composition; Purpose.

There is hereby established a Community Action for Recovery, Education and Support ("CARES") Committee which shall be composed of no more than 15 members, not including the Mayor who may serve as an ex-officio nonvoting member of the Committee. To the extent possible, members of the Board shall be representative of the community.

The purpose of the CARES Committee is to prevent and reduce substance use and behavioral additions and to promote mental wellness in the Borough of Metuchen by raising awareness and providing education through programs focused on prevention and recovery.

The Mayor and Council in its discretion may provide the Committee an annual budget to the CARES Committee for funding and sponsoring programs and promoting mental wellness consistent with the purpose set forth herein.

§ 10-36. Appointment; Selection of Chairperson; vacancies.

- A. All 15 members of the CARES Committee are to be appointed by the Mayor with the advice and consent of the Council. Membership shall include the following:
 - (1) One member of the Borough Council, who shall serve as a voting member.
 - (2) A representative from the Police Department, the Chief or his designee, who shall serve as a voting member.
 - (3) The Board shall include a volunteer psychological counselor, who shall serve as a voting member.
 - (4) A representative of the Board of Education, who shall serve as a voting member.
 - (5) Eleven residents of Metuchen, at least one of whom shall be under the age of 18, all of which shall be voting members, except for the elected Chairperson, who shall only be eligible to vote in the event of a tie.
- B. To the extent possible, of the eleven (11) members set forth in Section 6 above, the Mayor and Council shall consider the following for appointment to the Committee: a Student Assistance Coordinator or another student support services staff member; a representative of Parent-Teacher Organizations or Home School Association; Parents and/or Guardians of Borough students; a representatives of local faith-based organizations; Individuals who have been affected by substance use disorders and/or behavioral addictions, including those affected by their own or a family member's addiction; private citizens with interest in issues concerning substance use, addiction, and juvenile delinquency; representatives of local civic or volunteer groups; representatives from Youth Services Organizations; representatives of local businesses; a Senior representative; Citizen health and human services agencies/professionals; including healthcare professionals including pharmacists, physicians, or therapists; representatives of public and private organizations involved in the prevention and treatment of substance use disorders and behavioral addictions; and/or representatives of the local communications media or public relations to serve on the CARES Committee.
- C. The terms of the members appointed under Subsection A(1) and A(4) shall be coextensive with their terms of office. The remaining members shall be appointed for terms of three years. However, at the time of the passage of this amendment to this Article, all present members of the Municipal Alliance Youth Service Board shall continue to serve in that capacity as members on the CARES Committee until the expiration of their current terms. Any

vacancies on the current Municipal Alliance — Youth Service Board, to the extent possible, shall be filled for terms to be determined by the Mayor with the consent of the Borough Council. Thereafter, each appointment to the CARES Committee shall be for three years. Members shall serve after the expiration of their terms until their respective successors shall have been appointed and have qualified. Vacancies occurring other than by the expiration of the term shall be filled in like manner, but for the balance of the unexpired term only. The Board shall advise the Mayor and Council of any vacancies among its membership. The determination of a vacancy on the Board shall be determined by the Council of the Borough based upon the criteria set forth in the Municipal Vacancy Law, N.J.S.A. 40A:16-1 et seq. The Board shall designate one of its members as Chairperson, and they shall serve as such until the first day of January next following the appointment and until their successor shall be appointed and qualify. The Chairperson shall only be eligible to vote on Committee matters in the case of a tie vote. All members shall serve without compensation.

§ 10-37. Powers and duties.

The CARES Committee shall have the following powers and duties:

- A. Determine through an annual assessment of community-based needs, the scope and depth of substance use and behavioral addictions in the Borough of Metuchen and to provide comprehensive community-based prevention programs and outreach.
- B. Organize and coordinate efforts with the Borough of Metuchen schools, faith-based groups, youth members of the community, law enforcement, business groups and other community organizations for the purpose of reducing substance use disorders and behavioral addictions, as well as promoting mental wellness.
- C. Provide comprehensive substance use and behavioral addiction education, support and outreach efforts for parents and other adults in the community.
- D. Establish, amend and supplement its own bylaws, select other officers, and create any such sub-committees, to govern its structure, operations and activities to the extent not inconsistent with this Article or any other local, state or federal regulation or law.
- E. Make recommendations to the Mayor and Council of the Borough of Metuchen and other Borough agencies with respect to any matters relating to the existence of any grants or funding available to the Borough to further the purpose and intent of the Committee.

- F. Create and foster a network of community leaders, private citizens, and representatives from public and private human service agencies who are dedicated to supporting and developing ed educational programs which prevent and/or reduce substance use disorders and behavioral addictions.
- G. Conduct an assessment of the community-wide needs pertaining to mental wellness and addiction.
- H. Identify existing efforts and services that are acting to prevent and reduce substance use disorders and behavioral addictions and to coordinate projects within the Borough to avoid fragmentation and duplication.
- Develop programs and/or projects to be implemented at the Borough level or participate in regionally developed programs that accomplish the purpose of the Committee.
- J. Report to the Mayor and Council on at the very least a quarterly annual basis or as requested by the Mayor and/or Council.

BE IT FURTHER ORDAINED by the Mayor and Council that all prior ordinances, or sections of ordinances, inconsistent with the within ordinance are hereby repealed.

BE IT FURTHER ORDAINED by the Mayor and Council that all remaining sections of Chapter 10 not amended herein shall not be affected thereby and shall remain in full force and effect.

BE IT FURTHER ORDAINED by the Mayor and Council that if any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall continue in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable; and

BE IT FURTHER ORDAINED by the Mayor and Council that this ordinance shall become effective immediately upon final passage and publication as provided by law.

ORDINANCE 2023-09

Borough of Metuchen County of Middlesex State of New Jersey

ORDINANCE AMENDING THE CODE OF THE BOROUGH OF METUCHEN AND THE COMPOSITION OF THE PARADE COMMISSION INCREASING ITS MEMBERSHIP FROM FIVE (5) MEMBERS TO SEVEN (7) MEMBERS

WHEREAS, the Mayor and Council of the Borough of Metuchen have determined that it is in the best interest of the Borough to amend the composition of the Parade Commission of the Borough of Metuchen to increase its membership from five (5) members to seven (7) members.

NOW THEREFORE BE IT ORDAINED, by the Council of the Borough of Metuchen that it hereby amends Chapter 10, Article 13 of the Code of the Borough of Metuchen, specifically § 10-44, entitled "Establishment; composition" to state as follows:

Article 13. Metuchen Parade Commission

§ 10-44. Establishment; composition.

There is hereby established a Metuchen Parade Commission to organize, oversee and conduct the two parades annually in the Borough: 1) the Memorial Day Parade; and 2) the Winter Festival Parade for the Borough of Metuchen. The Parade Commission shall be made up of five seven members. The membership of the Commission shall be composed of residents of, or owners or operators of businesses in the Borough of Metuchen. At least one member of the Commission shall have served, or is currently a member of one of the branches of the United States Armed Forces. Each member's term of office shall be for a period of three years on a staggering basis. The initial appointment of its initial five members shall be as follows: two members for a term of three years; two members for a term of two years and one member for a term of one year. The initial appointment of the two (2) additional members shall be as follows: one member for a term of three years; and one members for a term of two years. Thereafter, the term of all of its members shall be for a period of three years.

BE IT FURTHER ORDAINED, by the Mayor and Council that all prior ordinances, or sections of ordinances, inconsistent with the within ordinance are hereby repealed.

- **BE IT FURTHER ORDAINED,** by the Mayor and Council that all remaining sections of Chapter 10, Sections 45 through 46 not amended herein shall not be affected hereby and shall remain in full force and effect.
- **BE IT FURTHER ORDAINED,** by the Mayor and Council that if any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance,

which shall continue in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable.

COOPERATIVE PRICING AGREEMENT

This agreement, made and entered into this _____day of _________, 20____, by and between the Board of Directors of Hunterdon County Educational Services Commission, referred to as the "Lead Agency" and various governing boards, authorities, commissions and other governmental contracting units within the State of New Jersey.

WITNESSETH

WHEREAS, the Lead Agency is conducting a voluntary Cooperative Pricing System with boards of education, municipalities, and other types of public bodies located within the State of New Jersey, utilizing the Lead Agency's administrative purchasing services and facilities in order to effect substantial economies in the purchase of work, materials and supplies; and

WHEREAS, the Cooperative Pricing System is authorized by N.J.S.A. 40A: 11-11 and has been approved by the Division of Local Government Services in the Department of community Affairs pursuant to N.J.A.C. 5:34-7.1 et seq., and

WHEREAS, all the parties hereto shall approve this Agreement by Ordinance or Resolution, as appropriate, in accordance with the aforesaid statue; and

NOW, THEREFORE, it is mutually agreed as follows:

- The work, materials or supplies to be priced cooperatively may include fuels, office supplies, paper products, instructional materials and equipment, vehicles, modulars and such other items and services as two or more participating contracting units in the system agree can be purchased on a cooperative basis.
- 2) Upon approval of the Cooperative Pricing System and during each January thereafter, the Lead Agency shall publish a legal ad in such format as required by the State Division of Local Government Services in a newspaper normally used for such purpose by it, to include such information required by N.J.A.C. 5:34-7.9. as may be amended from time to time, including:

- a. The name of the participating contracting unit, and
- b. The name of the Lead Agency soliciting competitive bids or informal quotations, and
- c. The address and telephone number of Lead Agency, and
- d. The State Identification Code for the Cooperative Pricing System,
- e. The expiration date of the Cooperative Pricing Agreement.
- Each of the participating contracting units shall indicate, in writing to the Lead Agency, the items to be purchased by the contracting unit, the approximate quantities desired, the location for delivery and other such requirements necessary for the Lead Agency to prepare specifications as provided by law. Although the Lead Agency endeavors to serve the needs of all registered members of the Cooperative Pricing System, the Lead Agency may not be able to prepare specifications and/or solicit bids for all projects and makes no such guarantee.
- 4) The specifications shall be prepared and approved by the Lead Agency and filed as required by law, and no changes shall thereafter be made except as permitted by law. Nothing herein shall be deemed to prevent changes in specifications for subsequent purchases.
- A single advertisement for bids/proposals or the solicitation of informal quotations for the work, materials or supplies to be purchased shall be presented by the Lead Agency on behalf of all registered members desiring to purchase any item in the Cooperative Pricing System. All advertisements and solicitations shall be made in compliance with the Public School Contracts Law.
- 6) The Lead Agency shall receive bids or quotations on behalf of all participating contracting units. The Lead Agency shall review said bids and, on behalf of all registered members, either reject all bids, or award a contract in compliance with the Public School Contract Law and the specifications. This award shall result in the Lead Agency entering into a master contract with the successful bidder(s) providing for two categories of purchases:
 - a. The quantities ordered for the Lead Agency's own needs, and
 - b. The estimated aggregate quantities to be ordered by other participating contracting units by separate contract, subject to the specifications and prices set forth in the Lead Agency's overall (master) contract.

The Lead Agency shall enter into a formal written contract(s) directly with the successful bidder(s) when required by law and, only after the Lead Agency has certified the funds available only for its own needs. Each registered member shall: (1) certify that it has the funds available necessary for its own order(s) from the Cooperative Pricing System; (2) enter into a formal written contract directly with the successful bidder(s) when required by law and the project specifications; (3) issue purchase orders in its own name directly to the successful bidder(s) against said contract; (4) accept its own deliveries; (5) be invoiced by and receive statements from the successful bidder(s) and (6) be responsible for any tax liability. No registered member shall be responsible for payment for any items ordered or for performance generally, by or to any other registered member. Each registered member shall accordingly be liable only for its own performance and for items ordered and received by it.

The provisions of this paragraph shall be quoted or referred to and sufficiently described in all advertisements for bids by the Lead Agency so that each bidder shall be on notice as to the respective responsibilities and liabilities of the registered members.

- Nothing in this Agreement shall prevent any registered member from awarding contracts of purchase, individually and on its own behalf, with or without advertising, except that invitations for such individual bids shall not be advertised nor bids be received during the period in which the Lead Agency is advertising for and receiving bids for the same items or commodities other than, in the case of the registered member's emergency or hardship.
- 8) The Lead Agency reserves the right to exclude any item or commodity from within said system if, in its opinion, the pooling of purchasing requirements or needs of the participating contracting units is either not beneficial or not workable as to the Lead Agency or the registered members..
- The Lead Agency shall appropriate sufficient funds to enable it to perform the administrative responsibilities assumed pursuant to this Agreement. It is understood that all fees for each participating contracting unit are paid to the Lead Agency by the successful bidder(s) with the exception of the fuel participation. This amount shall be paid forty-five (45) days from the receipt of billing from the Lead Agency.
- This agreement shall become effective upon approval of the Director of the Division of Local Government Services and shall continue in effect for a period of five (5) years pursuant to N.J.A.C. 5:34-7.5(f), or until a party to this Agreement shall give written notice of its intention to terminate its participation in the Cooperative Pricing System..
- All records or documents maintained or utilized pursuant to terms of this Agreement shall be identified by the code number assigned by the Director, Division of Local Government Services and such other numbers as are assigned by the Lead Agency for purposes of identifying each contract and item awarded.

- Additional local contracting units may from time to time, execute this Agreement by means of a Rider annexed hereto, which addition shall not invalidate this agreement with respect to other signatories. The Lead Agency is authorized to execute the Rider on behalf of the members of the System.
- 13) This Agreement shall be binding upon and inure to the benefit of the successors and assigns of the respective parties hereto.

LEGAL AUTHORITY:

WHEREAS, N.J.S. 40A:11-11 (5), specifically authorizes two or more contracting units to enter into a Cooperative Pricing System and Agreement for the purchase of work, materials and supplies; and

WORK TO BE PERFORMED:

WHEREAS, the Passaic Valley Sewerage Commission will conduct a Cooperative Pricing System with Participating Contracting Units, utilizing administrative purchasing services and facilities of the PVSC; and this Cooperative Pricing Agreement is to effect substantial economies in the purchase of goods and supplies; and

Municipal Utilities Authority, Landis Sewerage Authority, Cinnaminson Sewerage Authority, Township of South Orange Village, Stony Brook Regional Sewerage Authority, Borough of Alpha, Pennsauken Sewerage Authority, Raritan Township Municipal Utilities Authority, Borough of Peapack and Gladstone, Township of Bedminster, Borough of Franklin, Dover Township, Franklin Township Sewerage Authority, Franklin Township Sewerage Authority, Borough of Sea Bright, Township of Hamilton, Borough of Bernardsville, Wanaque Valley Regional Sewerage Authority, Borough of Pennington, Lakewood Township Sewerage Authority, Byram Township, Township of Pemberton, Borough of Avon by the Sea, Township of Florence, Hanover Park Regional High School District, City of Somers Point, Township of Cedar Grove, Borough of New Providence, Township of Tewksbury, Clinton Township Sewerage Authority, City of Summit, Old Bridge Municipal Utilities Authority, Willingboro Municipal Utilities Authority, City of Wildwood, Borough of Newfield, Borough of Rockaway, Montville Township Board of Education, Borough of Wenonah, Rockaway Township Board of Education, Brick Township Municipal Utilities Authority, Township of Montclair, Township of Clark, Borough of Hightstown, Borough of Manasquan, Township of West Orange, North Plainfield Board of Education, County of Hudson, the Borough of Caldwell, Municipality of Princeton, Township of Monroe, Bordentown Sewerage Authority, City of Plainfield, Borough of Red Bank, Township of Allamuchy, City of Trenton, Borough of Rumson, the North Arlington-Lyndhurst Joint Meeting, the County of Essex, the Evesham Municipal Utilities Authority, the Borough of Hopatcong, the Atlantic City Municipal Utilities Authority, the Pine Hill Borough Municipal Utilities Authority, the Township of Holmdel, the Township of Berkeley Heights, the Borough of Woodcliff Lake, and the Cumberland County Improvement Authority as well as other approved and appropriate Public Agencies within New Jersey; and

WHEREAS, all parties hereto have approved the within Agreement by Ordinance or Resolution as appropriate, in accordance with the aforesaid statute; and

WHEREAS, it is the desire of all parties to enter into such Agreement for said purposes;

NOW, THEREFORE, in consideration of the conditions hereinafter set forth, it is mutually agreed as follows:

1. The goods or supplies to be priced cooperatively may include Spare Parts, Instrumentation Equipment, Maintenance Chemicals, Motor Repair/Replacement, Mechanical Seals, Safety Equipment, Electrical Equipment, Laboratory Supplies, Bulk Chemicals and such other items as two or more participating contracting units in the system agree can be purchased on a cooperative basis, providing the PVSC consents to these other items.

The items and classes of items which may be designated by the participating contracting units hereto may be purchased cooperatively for the period commencing with the execution of this Agreement and continuing until terminated as hereinafter provided. ADMINISTRATION AND OPERATION OF SYSTEM:

2. The PVSC, on behalf of all participating contracting units, at the beginning of participating in the NJWCPS, and during each January thereafter, shall publish a legal advertisement in such format as required by the State Division of Local Government Services in a newspaper normally used for such purposes by it to include such information as:

(1) The name of the participating contracting units, and

(2) The name of the Cooperative Pricing System soliciting competitive bids or informal quotations, and

(3) The address and telephone number of the NJWCPS, and

(4) The State Identification Code for the Cooperative Pricing System, and

- (5) The expiration date of the Cooperative Pricing Agreement.
- 3. The specifications shall be prepared and approved by the NJWPCS and filed as required by law, and no changes shall thereafter be made except as permitted by law. Nothing herein shall be deemed to prevent changes in specifications for subsequent purchases.
- 4. The NJWPCS may provide the Participating Units with the copies of the specifications at least thirty (30) days prior to seeking bids and will notify the Participating Contracting Units, in writing, of the item(s) on which it will seek bids. Fifteen (15) days prior to advertising, each of the participating contracting units shall designate, in writing, to the NJWCPS, the items to be purchased and indicate therein the approximate quantities desired, the location for delivery and other requirements, to permit the preparation and filing of specifications as provided by law.

The NJWPCS will call a meeting of all Participating Contracting Units each December in order to provide the participants with an opportunity to discuss the goods or services to be priced cooperatively and the terms of the specifications for the next calendar year.

- 5. A single advertisement for bids or the solicitation of informal quotations for the goods or services to be purchased shall be presented on behalf of all of the Participating Contracting Units desiring to purchase any item by the NJWPCS in the Cooperative Pricing System.
- 6. In seeking bids the NJWCPS will include in the specifications two categories upon which bids are sought: (a) the NJWCPS's requirements, stated in definite quantities; and (b) the Participating Contracting Units, stated as an estimated total quantity of the needs of all the other Participating Contracting Units, which total shall not be exceeded in the aggregate by more than 20 percent of the total cost awarded for that Category. The specification for this category shall list the other Participating Contracting Units, their delivery address, their estimated maximum quantities and other relevant information to permit the bidder to understand what is potentially involved. The bids will contain: (1) a provision stating that contracts shall be in compliance with N.J.A.C. 5:30-5.5 (B), open-end contract rules; and (2) language requiring the bid price(s) to be stated so that it is uniform with respect to both categories (the NJWCPS and other Participating Contracting Units).

The provision with respect to the other contracting units category will allow the bidder to indicate if it is willing to provide the item(s) bid upon to other participating contracting units in the system; or if it is not willing to extend prices to other participating units in the systems.

- 7. The NJWCPS shall advertise for bids or the solicitation of informal quotations and shall receive bids or quotations on behalf of all Participating Contracting Units. Following the receipt of bids, the NJWCPS shall review said bids and on behalf of all Participating Contracting Units, either reject all or certain of the bids or make an award to the lowest responsible bidder or bidders for each separate item. This award shall result in the NJWCPS entering into a master contract with the successful bidder(s)
- 8. The NJWCPS shall enter into a formal written contract(s), when required by law, directly with the successful bidder(s) only after it has certified the funds available only for its own needs ordered. Each Participating Contracting Unit shall also certify the funds available only for its own needs ordered; enter into a formal written contract, when required by law, directly with the successful bidder(s); issue purchase orders in its own name directly to the successful bidder(s)against said contract; accept its own deliveries; be invoiced by and receive statements from the successful bidder(s); make payment directly to the successful bidder(s); and be responsible for any tax liability. No Participating

Contracting Unit in the Cooperative Pricing System shall be responsible for payment for any items ordered or for performance generally, by any other Participating Contracting Units and shall accordingly be liable only for its own performance and for items ordered and received by it and none assumes any additional responsibility or liability. The provisions of this paragraph shall be quoted or referred to and sufficiently described in all advertisements for bids by the NJWCPS so that each bidder shall be on notice as to the respective responsibilities and liabilities of the Participating Contracting Units. The NJWCPS shall supply the Participating Contracting Units with copies of the specifications, name of successful bidder, prices awarded and the contract identification number. Each Participating Contracting Unit may then order directly from that vendor by purchase order if under the appropriate statutory bid limit or by contract of the governing body or agency if over the appropriate statutory bid limit. The identification number shall be affixed to each purchase order or contract and shown on all forms pertaining thereto.

- 9. If the lowest responsible bidder declines to extend prices to the Participating Contracting Units all bids shall be rejected and no further bids will be sought by the NJWCPS on behalf of the Participating Contracting Units.
- 10 . A bidder shall not be required or permitted to extend his bid prices to Participating Contracting Units unless he has voluntarily agreed to do so as part of his bid.
- 11. Nothing in this Agreement shall prevent any Participating Contracting Unit from awarding contracts of purchase, with or without advertising, individually and on its own behalf, provided, however, that invitations for such individual bids shall not be advertised, nor shall bids be received individually, during the period in which the NJWCPS is advertising for and receiving bids for the same goods or services, except in the case of emergency or hardship.
- 12. No purchase order or contract shall be issued by any Participating Contracting Unit for a price which exceeds any other price available to it from any other such system in which it is authorized to participate or from bids which it has itself received.
- 13. The NJWCPS reserves the right to exclude any goods or services from within said system if, in its opinion, the pooling of purchasing requirements or needs of the Participating Contracting Units is either not beneficial or not workable.

ADMINISTRATIVE COSTS:

14. The PVSC shall bear all costs associated with administering the Cooperative Pricing system and bidding process including cost of advertising and administration and the Participating Contracting Units shall not be obligated for any part of such expenses.

DURATION AND TERMINATION:

- 15. This Agreement shall become effective the date executed, subject to the approval of the Director of the Division of Local Government Services and shall continue in effect for a period not to exceed five (5) years from said date or the term of the current approval unless any party to this Agreement shall give written notice of its intention to terminate its participation at least 30 days prior to the succeeding four (4) years. The NJWCPS may choose to terminate registration of the system no later than 30 days prior to the expiration date of the system. Renewal of the system will be in accordance with the provisions of N.J.A.C. 5:34-17.6, as may be amended.
- 16. This Agreement and the Cooperative Pricing System will not terminate nor be invalidated by the PVSC or the withdrawal or addition of any Participating Contracting Unit. However, this Agreement and the Cooperative Pricing System shall be terminable and invalidated at the instance of the NJWCPS upon written notice to the Participating

Contracting Unit and without recourse against the NJWCPS for any reason or if continuance of the within system becomes unlawful for any reason.

DOCUMENTATION:

- 17. All records and documents maintained or utilized pursuant to the terms of this Agreement shall be identified by the code number assigned by the Director, Division of Local Government Services, and such other numbers as are assigned by the NJWCPS for purposes identifying each contract and item awarded.
- 18. This Agreement shall be binding upon and inure to the benefit of the successors and assigns of the respective parties hereto.



MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING (this "MOU") dated as of _______, 2023 by and between METUCHEN SENIOR REDEVELOPERS, LLC having an address of 307 Bloomfield Ave, Suite 303, Caldwell, NJ 07006 and/or its assignee, as provided herein (the "Conditional Redeveloper"), and the BOROUGH OF METUCHEN, a municipal corporation of the State of New Jersey, having offices at 500 Main Street, Metuchen, New Jersey 08840 (the "Borough"), collectively referred to as the "Parties."

WHEREAS, the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40A:12A-1, <u>et seq.</u>, as amended and supplemented ("Redevelopment Law"), provides a process for municipalities to participate in the redevelopment and improvement of areas in need of rehabilitation or redevelopment; and

WHEREAS, the Borough, pursuant to N.J.S.A. 40A:12-1 et seq., via Resolution 2015-147, adopted on June 15, 2015, formally declared Block 71, Lot 37.01, within the Borough of Metuchen as an area in need of redevelopment (the "Oakite Redevelopment Area"); and

WHEREAS, the Borough, pursuant to <u>N.J.S.A.</u> 40A:12-1 et seq., via Resolution 2020-50, adopted on February 3, 2020, formally declared the entirety of the Borough of Metuchen as an area in need of rehabilitation (the "Rehabilitation Area"); and

WHEREAS, in order to facilitate the redevelopment of the Oakite Redevelopment Area, the Borough adopted Ordinance 2018-24, adopting the "Oakite Site Redevelopment Plan, Borough of Metuchen, New Jersey, Block 71, Lot 37.01" ("Oakite Redevelopment Plan"); and

WHEREAS, in order to facilitate the redevelopment of the Rehabilitation Area, the Borough adopted Ordinance 2020-10, adopting a Redevelopment Plan for the Entirety of the

Borough of Metuchen, a Designated Rehabilitation Area ("Boroughwide Redevelopment Plan"); and

WHEREAS, the Redevelopment Law, <u>N.J.S.A</u>. 40A:12A-8(f), authorizes the Borough to arrange or contract with a redeveloper for the undertaking of any project or redevelopment work in an area designated as an area in need of rehabilitation or redevelopment; and

WHEREAS, the Borough has been in discussions with Conditional Redeveloper regarding redevelopment of a portion of the Oakite Redevelopment Area known as Parcels "B" and "D" within Block 71, Lot 37.01 as well as a portion of Block 71, Lot 37.02 within the Rehabilitation Area (the "Project Site"); and

WHEREAS, the Conditional Redeveloper is under contract with the current title owner to purchase Parcels "B" and "D" within the Project Site; and

WHEREAS, the redevelopment work may call for, among other things, rehabilitation and/or demolition of existing improvements and construction of new improvements, including an over-55 apartment complex (the "Project Improvements"); and

WHEREAS, the Borough and Conditional Redeveloper have engaged in such preliminary negotiations and the Borough has determined that it is in the best interests of the Borough to enter into additional negotiations with Conditional Redeveloper and therefore to enter into this MOU with Conditional Redeveloper regarding redevelopment of the Project Site.

NOW, THEREFORE, in consideration of the Parties' promises and mutual representations, covenants and agreements set forth herein, the Parties, each binding itself, its successors and assigns, do hereby mutually promise, covenant and agree as follows:

1. <u>Designation as Conditional Redeveloper</u>. The Borough has, pursuant to Resolution No. 2023- ____, designated Metuchen Senior Redevelopers, LLC as Conditional

Redeveloper for the Project Improvements on the Project Site within the Oakite Redevelopment Area and Rehabilitation Area and, pursuant to this MOU, hereby agrees to negotiate solely with Conditional Redeveloper for a period of one hundred and eighty (180) days from the date of this MOU, in good faith, for the redevelopment and rehabilitation of the Project Site, which period can be extended by the Parties' mutual written agreement.

- 2. **Redevelopment Agreement**. The Parties hereby agree to immediately commence good faith negotiations of the intended terms and conditions of a Redevelopment Agreement and other agreements, which shall include, but not be limited to, provisions for the following: project schedule; financial guarantee(s); compliance with the Redevelopment Plans; local planning approval; and project oversight.
- The "Interim Period". Conditional Redeveloper shall pay the Borough all Interim Costs (as defined below) incurred by the Borough during the time period commencing when the Borough reviewed the Conditional Redeveloper's initial proposal to the time the Borough and Conditional Redeveloper enter into a Redevelopment Agreement or the time the Borough or the Conditional Redeveloper determines that a Redevelopment Agreement cannot be executed for any reason (hereinafter referred to as the "Interim Period"). Conditional Redeveloper shall pay all Interim Costs even if a Redevelopment Agreement cannot be executed for any reason.

4. **Payment of "Interim Costs"**.

A. "<u>Interim Costs</u>" shall include all reasonable fees and costs of any professional consultant, contractor, legal counsel or vendor retained by the Borough during the Interim Period in connection with the negotiation of the Redevelopment Agreement, preparation of amendments to the Redevelopment Plans and review of plans for the redevelopment of the Project Site.

- B. Interim Fund. Within three (3) business days of the execution of this MOU, Conditional Redeveloper shall establish a separate escrow account with the Borough by depositing the amount of Fifteen Thousand Dollars (\$15,000.00) ("Interim Fund") to be drawn down by the Borough to pay Interim Costs. If the Interim Fund is drawn down to Three Thousand Five Hundred Dollars (\$3,500.00), the Borough shall notify Conditional Redeveloper in writing and Conditional Redeveloper shall replenish the Fund to the initial deposit amount as required herein within twenty (20) days. If the Interim Fund is not so replenished, the Borough may terminate this Agreement upon delivery of a Letter of Termination from the Borough to Conditional Redeveloper or its legal representative, providing a period of seven (7) days, to replenish the Interim Fund before such termination is effective. In the case of termination, Conditional Redeveloper shall be responsible to immediately pay all costs due up to the date of termination. Except as otherwise specifically provided herein, the Interim Fund shall be administered in accordance with N.J.S.A. 40:55D-53.1 and N.J.S.A. 40:55D-53.2.
- C. <u>Statement and Invoices</u>. The Borough shall provide Conditional Redeveloper with monthly invoices during the course of the Interim Period, setting forth the Interim Costs incurred by the Borough which the Borough determines are to be paid from the Interim Fund. The Borough shall provide a final invoice within thirty (30) days of the date a Redevelopment Agreement is executed, or the date the Borough determines that such an agreement cannot be executed.
- D. <u>Disposition of Interim Fund Balance</u>. Any balance in the Interim Fund upon execution of the Redevelopment Agreement shall be refunded to the Conditional Redeveloper at the end of the Interim Period.
- 5. <u>Amendments.</u> Any and all amendments to this MOU shall be in writing and shall require the mutual agreement of both Parties.

- 6. **Entire Agreement**. This MOU sets forth all of the promises, covenants, agreements, conditions and undertakings between the Parties hereto with respect to the subject matter hereto, and supersedes all prior or contemporaneous agreements and undertakings, inducements or conditions, express or implied, oral or written, between the Parties hereto.
- 7. **Not Binding on Individuals**. No covenant, condition or agreement contained in this MOU shall be deemed to be the covenant, condition or agreement of any past, present or future member, manager, trustee, official, officer, agent or employee of either Party, in his or her individual capacity, and neither the members, managers, trustees, officials, officers, agents or employees of such Party or Parties, nor any individual executing this MOU, shall be personally liable on this MOU or by reason of the execution hereof by such person, or arising out of any transaction or activity relating to this MOU.
- 8. <u>Governing Law</u>. The terms of this MOU shall be governed, construed, interpreted and enforced in accordance with the laws of the State of New Jersey, including all matters of enforcement, validity and performance.
- 9. Non-Binding Effect. Except for the Borough's obligation to negotiate exclusively and in good faith with Conditional Redeveloper, as well as Conditional Redeveloper's obligation to negotiate in good faith and to be responsible for all Interim Costs, this MOU does not constitute a binding commitment between the Parties hereto, as the Parties' respective rights and obligations remain to be fully defined in their Redevelopment Agreement(s).
- 10. <u>Counterparts.</u> This MOU may be executed in counterparts. All such counterparts shall be deemed to be originals and together shall constitute but one and the same instrument.
- 11. **Effective Date**. This MOU shall become effective upon the execution of this MOU by both parties.

12. <u>Electronic Signature</u>. Electronic delivery via email and/or fax of an executed MOU by either and/or both parties shall bind the signatory entity to the same extent as delivery of a hard copy.

RESOLUTION AUTHORIZING THE CREATION OF THE COMMUNITY ACTION FOR RECOVERY, EDUCATION, AND SUPPORT ("CARES") COMMITTEE

WHEREAS, Article 10, of Chapter 10 of the Code of the Borough of Metuchen established a Municipal Alliance – Youth Service Board and provided for the appointments of its members and the powers and duties of the Board; and

WHEREAS, the Mayor and Council of the Borough of Metuchen have determined that it is in the best interest of the Borough to prevent and reduce substance abuse and behavioral addictions and to promote mental wellness in the Borough by raising awareness and providing education focused on prevention and recovery; and

WHEREAS, the Mayor and Council of the Borough of Metuchen have determined that it is in the best interest of the Borough to restructure the Municipal Alliance Board – Youth Service Board and to create the Community Action Recovery, Education and Support ("CARES") Committee to operate in its stead; and

WHEREAS, the Mayor and Council have determined that pending the final adoption of the amendment to the Borough Code and passage of the appropriate Ordinance it is in the best interest of the Borough to authorize the creation of the Community Action Recovery, Education and Support ("CARES") Committee pending the final adoption and of the amendment to the Borough Code and passage of the appropriate Ordinance.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Metuchen that it hereby authorizes the restructuring of the Metuchen Municipal Alliance Board – Youth Service Board and the creation of the Community Action Recovery, Education and Support ("CARES") Committee; and

BE IT FURTHER RESOLVED by the Mayor and Council that the purpose of the CARES Committee is to prevent and reduce substance use and behavioral additions and to promote mental wellness in the Borough of Metuchen by raising awareness and providing education through programs focused on prevention and recovery' and

BE IT FURTHER RESOLVED by the Mayor and Council that pending final adoption of Amendments to the Borough Code and the Ordinance creating the CARES Committee, the Mayor and Council hereby authorizes that the CARES Committee shall have the following powers and duties: (a) to determine through an annual assessment of community-based needs, the scope and depth of substance use and behavioral addictions in the Borough of Metuchen and to provide comprehensive community-based prevention programs and outreach; (b) Organize and coordinate efforts with the Borough of Metuchen schools, faith-based groups, youth members of the community, law enforcement, business groups and other community organizations for the purpose of reducing substance use disorders and behavioral addictions, as well as promoting mental wellness; (c) provide comprehensive substance use and behavioral addiction education, support and outreach efforts for parents and other adults in the community; (d) establish, amend and supplement its own bylaws, select other officers, and create any such sub-committees, to

govern its structure, operations and activities to the extent not inconsistent with this Resolution and adopted Ordinances or any other local, state or federal regulation or law; (e) make recommendations to the Mayor and Council of the Borough of Metuchen and other Borough agencies with respect to any matters relating to the existence of any grants or funding available to the Borough to further the purpose and intent of the Committee; (f) create and foster a network of community leaders, private citizens, and representatives from public and private human service agencies who are dedicated to supporting and developing educational programs which prevent and/or reduce substance use disorders and behavioral addictions; (g) conduct an assessment of the community-wide needs pertaining to mental wellness and addiction; (h) identify existing efforts and services that are acting to prevent and reduce substance use disorders and behavioral addictions and to coordinate projects within the Borough to avoid fragmentation and duplication; (i) develop programs and/or projects to be implemented at the Borough level or participate in regionally developed programs that accomplish the purpose of the Committee; (j) report to the Mayor and Council on at the very least a quarterly annual basis or as requested by the Mayor and/or Council; and

BE IT FURTHER RESOLVED by the Council that the CARES Committee shall be made up of up to fifteen (15) members, not including the Mayor who may serve in an ex-officio nonvoting member, wherein the representatives of which shall be designated in the Ordinance creating the CARES Committee; and

BE IT FURTHER RESOLVED by the Mayor and Council that all present members of the Municipal Alliance — Youth Service Board shall continue to serve in that capacity as member of the CARES Committee until the expiration of their current terms and any vacancies on the current Municipal Alliance — Youth Service Board, to the extent possible, shall be filled for terms to be determined by the Mayor with the consent of the Borough Council; and

BE IT FURTHER RESOLVED by the Mayor and Council that it hereby authorizes all Borough Officials, employees, and agents to take all action necessary for the implementation of the within Resolution and the creating of the Metuchen CARES Committee and the implementation of the Committees powers and duties.
