BOROUGH OF METUCHEN COUNCIL MINUTES May 22, 2023 7:30 PM

The Regular Meeting of the Borough Council was held in the Council Chambers of Borough Hall on Monday, May 22, 2023.

The Meeting was called to order at 7:30 p.m. by Mayor Busch.

Mayor Busch asked all to rise for the flag salute.

Adequate Notice of this meeting has been given in accordance with the Open Public Meeting Act, pursuant to Public Law 1975, Chapter 231. Said notice was sent to the Home News Tribune and Star Ledger on December 21, 2022, posted in Borough Hall, and on file in the Clerk's Office. All requirements of the "Open Public Meetings Act" have been satisfied.

Roll Call

Mayor Busch asked for a roll call.

Present were Councilmembers Branch, Hirsch, Hyman, Rasmussen, Council President Delia, and Mayor Busch. Councilmember Kandel was absent. Also present were Borough Administrator Melissa Perilstein, Borough Clerk Deborah Zupan, and Borough Attorney Denis Murphy.

Carol Savage, 59 Carson Avenue, commented that a tractor trailer had driven down her street, taking down power lines and damaging trees, possibly because detour signs had been incorrectly placed or moved. Ms. Savage also expressed concern for pedestrian safety in town, particularly by the intersection of Woodbridge Avenue and Main Street and suggested better signage for motorists. Finally, Ms. Savage noted that there is a lot of construction being done on Amboy Avenue which is leaving a lot of debris around, and that the contractor should be required to clean up the site.

Council President Delia

- Thanks to the MDA, there are advertisements for Metuchen at several NJ Transit stations. There are a number of MDA events coming up including the Pre-Prom Party, Downtown Pride, the Downtown Fun House, the Juneteenth celebration, and the Kids' Takeover.

- The Cannabis Subcommittee has submitted its report regarding the Cannabis Retailer application process, which was accepted earlier tonight. One applicant scored high enough to continue in the licensing process.

Mayor Busch announced that Council President Delia was given a prestigious award by Keep Middlesex Moving and thanked him for all he has done to make Metuchen streets safer.

Councilmember Rasmussen

- The Environmental Commission met last week and are continuing with their Weed Warrior project and have an upcoming event to remove invasive species in the area. The Commission has been discussing community solar and composting. The Commission is also going to be embarking on a 'Green' business recognition program along with the MDA.
- The Shade Tree Commission was downtown last weekend to prune suckers off the lower parts of Borough trees, and will be expanding this project to other parts of town.
- The Senior Commission currently has an art exhibit at the Library featuring paintings created by the Senior Center members. Please visit the Metuchen Seniors Facebook page, or the Borough website, for upcoming classes and events.

Councilmember Hyman

- The Parade Commission and many others are working hard to make sure this year's Memorial Day Parade, specifically the bring home of Staff Sargeant Michael Uhrin's remains, is a success and that it properly honors Staff Sargeant Uhrin. A service at Memorial Park will follow the parade. A winner of the Memorial Day poster contest was chosen; Bryn G., a fourth grader at Campbell School, created the winning design.
- The recent 'Coffee with a Councilmember' event at Beans and Bread, with Council President Delia, was a success.
- Metuchen CARES has a new website featuring information and resources on preventing and overcoming addiction. CARES is also supporting the High School's Project Graduation with donations and lawn signs.

Councilmember Hirsch

- The Library will be closed for Memorial Day weekend. A program on Container Gardening is scheduled for May 30, presented by Frederic Primich who is a Rutgers Master Gardener volunteer and a Metuchen resident. "How to Talk to Kids About Racism" will be offered on June 1, to parents and caregivers, from Tabitha and Adam St. Bernard-Jacobs who are educators and parents. This program is funded through the Martin Spritzer Fund to raise awareness for equity, civil rights, and antiracism. The 3rd Cornerstone Jazz Concert in the series will be presented by Grammy nominated Jazz Vocalist Roseanna Vitro and the Jazz Ambassadors which is scheduled for June 11.

- There was recently a meeting of a committee of residents to plan a temporary layout for the pocket park, located by the former location of Manasquan Bank. More updates on this soon
- The Recreation Commission had the Mayor's Bike Tour of Metuchen and Edison yesterday.
- The Arts Council will be hosting the Spring for Spring Dance Festival featuring dancers from Mignolo on June 4.
- The Human Relations Commission will be co-hosting the Downtown Pride event on June 3. Besides the Juneteenth event on June 17, there will be a panel on Hip Hop's 50th anniversary at Suite Metuchen on June 17.

WHEREAS, the Borough of Metuchen Tax Collector/Chief Finance Officer has computed an estimated tax levy in accordance with N.J.S.A. 54:4-66.3, and has signed a certification showing the tax levies for the previous year, the tax range, and the range of permitted estimated tax levies.

WHEREAS, there were 694 motor vehicle fatalities in New Jersey in 2022; and

WHEREAS, approximately 40% of the motor vehicle occupants killed in those traffic crashes were not wearing a seat belt; and
