BOROUGH OF METUCHEN COUNCIL MINUTES REORGANIZATION MEETING January 1, 2024 3:00 PM

The Reorganization Meeting of the Borough Council was held in the Council Chambers of Borough Hall on January 1, 2024.

The Meeting was called to order at 3:04 p.m. by the Borough Clerk, Deborah Zupan

Adequate Notice of this meeting has been given in accordance with the Open Public Meeting Act, pursuant to Public Law 1975, Chapter 231. Said notice was published in the Home News Tribune on December 19, 2023, posted in Borough Hall, and on file in the Clerk's Office. All requirements of the Open Public Meetings Act have been satisfied.

Invocation

The Invocation was delivered by Rabbi Bennett Miller.

Ms. Zupan asked all to remain standing for the flag salute.

Swearing-In of Elected Officials

Mayor-Elect Busch was sworn in by the Honorable Congressman Frank Pallone.

Councilmember-Elect Vinita Jethwani was sworn in by the Honorable Congressman Frank Pallone.

Councilmember-Elect Tyler Kandel was sworn in by the Honorable Congressman Frank Pallone.

Roll Call

Mayor Busch asked for a roll call.

Present were Councilmembers Branch, Delia, Giamboi, Hyman, Jethwani, Kandel, and Mayor Busch. Also present were Denis Murphy, Borough Attorney, Melissa Perilstein, Borough Administrator, and Deborah Zupan, Borough Clerk.

Election of Council President

Councilmember Kandel made a motion to nominate Councilmember Delia for Council President. Councilmember Hyman seconded the nomination. Mayor Busch asked if there were any other nominations. With no further nominations, Mayor Busch closed the nominations. Mayor Busch asked for a voice vote, with all in favor, Councilmember Delia was elected Council President for 2024, 6-0.

Mayor's Annual Address

Good afternoon everyone and thank you for attending Metuchen's 124th reorganization meeting. It is so meaningful for me to be sworn-in today by our Congressman and my good friend, the Honorable Frank Pallone Jr. When I was in high school, I spent two summers working for Congressman Pallone on Capitol Hill. I will always be grateful for Congressman Pallone's mentorship and for the opportunities that he and his office provided me during that particularly formative and impactful period in my life.

Congratulations to Council Member Tyler Kandel, who was just sworn-in to serve a second term. As Councilman, Tyler is always candid about sharing his opinions on matters, has excellent intuition, and provides great perspective which has greatly enhanced this body's work during his service to the Borough. I also congratulate and acknowledge our newest Council Member, Vinita Jethwani. She is incredibly bright, resourceful, and she is one of the hardest working people with whom I have ever worked. We are so grateful that you agreed to join us, Vinita.

It is hard to imagine that I have now served in this role for more than six years. Perhaps it feels like a lot longer for my wife Kathy, who has been at my side for every part of this journey and I am so thankful for her love and support. When I was first sworn in in December 2017, our boys were 13, 11 and six years old. Somehow, we now have a college freshman, a senior in high school and a middle schooler. Kathy and I often talk about how fast they've grown but we cannot think of anywhere else where we would rather raise them. This community, our home, is a truly special place and serving as its Mayor is the honor of my life. I am deeply grateful for the opportunity to continue to serve, even if I do have a bit more gray hair to show for it.

Our Extraordinary Year

It is quite apparent that we are in the midst of an extraordinary period in Metuchen's history. On this day last year, I described Metuchen as "enjoying a Golden Age of sorts" and our recent accomplishments have made us shine even brighter! But anyone who knows Metuchen understands that the brilliance of our community is a collective effort.

Clearly, they don't call us the Brainy Borough for nothing since this year, Metuchen had not one but two residents appear on Jeopardy! - Liz Durst Jensen was a first-time contestant and Alan Johnson returned for the Champions Wildcard Tournament. And speaking of twos, what are the chances that a Borough of 15,000 would have two Major League Baseball draft picks in the same year? Jay Harry was selected by the Minnesota Twins and Matt Boucher was selected by the Tampa Bay Rays. Nora Pagel returned to "Project Runway" after nearly 20 years for the "Project Runway All Stars" show. And then there is our own Council President Jason Delia, who was awarded the 2023 Keep Middlesex Moving George Ververides Outstanding Community Leadership Award for his leadership on issues of improving safety in the Borough for pedestrians and cyclists. And we must not forget the return of our hometown hero, Staff Sgt. Michael Uhrin, who died in combat over Germany during World War II and whose remains were finally interred at Hillside Cemetery on Memorial Day weekend, nearly 80 years from the date he left our beloved hometown.

We may be 2.7 square miles but we are truly mighty. Just last month, Metuchen was named Jersey's Best "2024 Destination of the Year" and earlier in the year, "Only in Your State" awarded us the title of "Best Walkable Town in New Jersey." Edgar Middle School celebrated its receipt of the coveted National Blue Ribbon School Award and, of course, the jewel in our crown was when Main Street America gave the Metuchen Downtown Alliance the "Great American Main Street Award." Metuchen is just the third community in all of New Jersey to have won this prestigious national award and it is, without question, one of the most important recognitions in the history of our Borough.

And speaking of our downtown, it is thriving! A number of our retail establishments have become recognized as some of New Jersey's Best; for example, Hailey's was ranked by nj.com as #9 on the list of best Irish pubs, Fresco was ranked as #24 on the list for best Italian delis, and What's the Scoop was #51 on the list of best ice cream shops. Also, Papillon & Company was recognized by the State of New Jersey as part of the State Senate's dual celebration of Black History Month and National Entrepreneurship Week.

Our downtown is the place to be. In spite of a downward trend in national retail sales, our downtown vacancy rate remains at a record low and we continue to receive significant investment interest from those who want to join our downtown community. We are so excited that Meximodo has opened its doors, helping the Borough finally realize its vision for a completed public plaza surrounded by retail and restaurants. Soon, the former pastry chef at Heirloom Kitchen will be opening Ram & Rooster, a Chinese-inspired new American eatery, and the retro video game arcade, Yestercades, will open here later this month, as its fourth location, joining Red Bank, Somerville and Westfield. And construction is now under way on Metuchen's very own Starbucks, located on Middlesex Avenue, directly across from Trailhead Park and the entrance to the Greenway.

Moving Metuchen Forward

It's easy to identify our most prominent and highly publicized projects to highlight how Metuchen is constantly moving forward, but our success is built upon the strong foundation that our everyday operation provides. In Metuchen, our elected officials and administrators are constantly looking for new and innovative opportunities to improve our quality of life and working to incorporate the values and concerns of residents into the way we govern. For example, while we have enhanced the way the Borough communicates through social media and Metuchen Media, residents asked us for even more ways to interact with the Borough. As a result, we partnered with Simplicity, an innovative mobile application, which enables residents to stay connected with everything going on in the Borough.

Many residents have shared their interest about having increased access to our Planning and Zoning Board meetings so, we have made the decision to televise and stream them this year so that residents can watch these meetings, even if they are unable to make it to Borough Hall. We have heard the community's desire for engaging public art in our community so we established a relationship with the Seward Johnson Atelier in Hamilton and this past summer, we joined a select number of other communities around the world to feature Johnson's sculptures when we placed three of them around Metuchen. Later this winter those sculptures will be replaced by five others at additional sites around the Borough. This partnership has also presented a variety of other opportunities for Metuchen including new curricular programming for our students in the Metuchen schools.

Speaking of the arts, we know how passionately our community feels about the Forum Theatre and the proposed Metuchen Arts District. As we have said many times, Borough officials have worked diligently on a plan for the creation of the Metuchen Arts District, the centerpiece for which will be the Forum Theatre. As part of those efforts this year, the Borough introduced a redevelopment plan and ordinance for an expanded vision of the Metuchen Arts District which reflects preservation, revitalization, repurpose, and reuse of the properties in the vicinity of the Forum as an inclusive place for arts, culture and history. Additionally, we recently adopted an ordinance that authorizes the Borough to commence formal proceedings to acquire the blighted gas station that is adjacent to the Forum. Also, during the summer, it was announced that our State Legislative delegation, led by Senator Diegnan, Assemblyman Karabinchak and Assemblyman Stanley, acquired another \$3 million for the eventual Arts District.

We knew from the moment we acquired the Forum that reopening it would take time, not just because of the theatre's structural issues or the pandemic, but because projects like these require vision, innovation, collaboration, methodical planning, and patience. We spend countless hours exploring the business operations and economic viability of the Forum and we are continuing to pursue a variety of simultaneous avenues in pursuit of our goal to bring the Arts District to life. It is a major priority of our administration but not at the expense of significant costs to our taxpayers. Thus, we will continue to pursue our goal of finding a self-sustaining business model that carries this project across the finish line. We are closer than we have ever been to achieving this objective but slow and steady will win the race.

Our community was excited two years ago that a scene from the critically-acclaimed film "Eileen" was shot on South Main Street. The studio paid the Borough for the opportunity to use our community as its backdrop and we recognized the potential that Metuchen's charm brings as a filming location which may result in an occasional source of revenue. Thus, within the last few months, we began taking steps to certify the Borough as "Film Ready" by the New Jersey Motion Picture & Television Commission, which will provide Metuchen with additional opportunities to be considered by the entertainment industry.

Since 2009, the Fuccile Foundation has been one of the most impactful local charities and our community has come to rely heavily on its work on behalf of families impacted by tragedy. Over the years, through private fundraising efforts, including the Fuce 5K and the Metuchen Cookie Walk, many families have been supported by the Fuccile Foundation. During the Fuce 5K this past June, Nancy Fuccile announced that The Foundation would cease operations at the end of 2023. During the last few months, Borough officials have been collaborating with Board Members from the Fuccile Foundation in an effort to join The Foundation with the concept of "It Takes a Borough," which we initially introduced in 2018 as a mechanism to support Metuchen families in need. We are thrilled to announce thatseveral of the Board members from the Fuccile Foundation, some of whom are here with us today, will be joining other dedicated volunteers to formally establish "It Takes A Borough" in 2024. Also known as iTAB, "It Takes a Borough" will carry the Fuccile Foundation's torch by continuing to host the beloved annual Fuce 5K and the Cookie Walk each year so that we can continue to support residents whose lives have been impacted by tragedy or unforeseen circumstances. At this time, I'd like to take a moment to recognize Nancy Fuccile, who in 2008, along with a group of others, created the Fuccile Foundation in honor of her late husband, Mike. Nancy, along with your children Michael, Jack and Brooke, you have turned an unspeakable circumstance into an extraordinary network of support for others impacted by tragedy and we are incredibly grateful for the groundwork that you and the Fuccile Foundation have laid for Metuchen's future. Thank you.

Public Safety And Pedestrianization

We continue working to keep the Borough among the safest places to live and raise a family in New Jersey. We are adding additional officers to our police department so that we can continue to implement our comprehensive community policing program, placing our officers at all types of Borough events, in our schools, and walking and biking throughout the Borough. Additionally, expanding our police force allows us to increase our traffic enforcement to make our roads safer.

It took many years of working with State officials but we have finally installed the exclusive left turn for cars turning left onto Middlesex Avenue at the intersection of Grove and Middlesex Avenues. This upgrade has already reduced unnecessary back-ups on Grove Avenue and made this busy intersection safer for both pedestrians and drivers. Also, we continue to work with Middlesex County officials to make major improvements to the intersection of Central and Durham Avenues. These improvements are expected to be implemented in time for any new pedestrian and vehicular traffic associated with the new Gulton project.

We are closer than ever to installing the Borough's first-ever bike lane on Metuchen's portion of Grove Avenue, which is yet another significant step toward making Metuchen more friendly for bicyclists. This year, we also received a State grant for another bike lane on Hillside Avenue that will connect Grove Avenue to our downtown. Also, studies show that placemaking goes hand-in-hand with traffic calming and pedestrianization so we continue to work with our Metuchen Downtown Alliance for ways to create friendly public spaces like "Conversation Corner" by the Senior Center on the corner of New and Central and the beautiful new mural entitled "Metuchen Magic" created by famous muralist, Ricardo Roig, located in the previously underutilized alleyway between Tribos Peri Peri and Menya.

We believe that 2024 will finally be the year when we will be able to implement \$9.3 million in substantial safety improvements to Main Street from the grant that was awarded back in 2018 - yes, some of these things take that long! This grant money will be used to address several known problems along Main Street - from Brunswick Avenue all the way to Talmadge Avenue.

As a specific response to resident concerns, we created new marked crossings at the corner of New and Pearl Streets so that it is easier for pedestrians to know where to most safely cross and, speaking of New Street, after years of our residents and downtown business owners requesting new sidewalks along New Street, we will be replacing them this Spring so they match-up well with the other downtown sidewalks that were replaced a few years ago. Also, with the help of Middlesex County officials,

we pushed back the stop line at Amboy and Main Streets to allow trucks to make wider right turns, which we hope will diminish the number of times that the traffic light pole at that intersection is knocked down.

With the extraordinary assistance of Congressman Pallone, the Borough was awarded a \$300,000 federal grant to make significant upgrades to our communication system for the Metuchen Fire Department. This much-needed funding will ensure that our first responders continue to effectively respond to emergencies.

And speaking of our first responders, we are making significant progress on our new Emergency Services Center, which will house our Fire Department, EMS and Office of Emergency Management to be located on the current EMS site at 98 Essex Avenue. We are so proud of how well representatives from the Borough, Metuchen Fire Department, and Metuchen EMS have worked together with the architect in these planning phases. Back in June, our State Legislative delegation was instrumental in securing \$2 million in State funding for this project and based on our current pace, we expect that we will be able to have shovels in the ground sometime in 2024.

Infrastructure And Recreation

We continue to make extensive progress on other imperative Borough infrastructure projects, as well. For example, this spring, we expect that construction will be complete on the Jersey Avenue Pump Station replacement project. This project is certainly not as exciting as some of our other projects but upgrading our Borough's wastewater management system to significantly improve the flow of sewage throughout Metuchen is, without question, as important a project as any we are currently working on.

A few weeks ago, we finally commenced the replacement of the Kahn's Crossing Pedestrian Bridge in the Graham Avenue neighborhood, which had been shut down for safety reasons in early 2018. The bridge's replacement was made possible by a 2021 grant award from the State's Transportation Trust Fund. We have been working towards this long overdue repair for years and it should finally be complete in the next few weeks.

The Borough continues to place significant emphasis on making major upgrades to Metuchen's parks and recreation infrastructure. We opened a downtown pocket park on the former site of the Manasquan Bank drive-through and with some simple landscaping; re-painting; re-purposing; and the addition of some tables, chairs, and string lights, we "popped up" a temporary iteration of the park for all of us to enjoy. Over the course of the next year, and with the help of another \$250,000 secured by our State Legislative delegation, we will be putting together a plan for a permanent iteration of the space, which will eventually be named for Thomas Mundy Peterson, Metuchen's most famous resident.

Demolition of the warehouses along Durham Avenue on the Gulton property is now complete and construction will soon be underway on the Gulton project, which in addition to a new apartment building that will be designed to reflect the site's green and industrial legacy, will include a 32-acre section of the Peter J. Barnes III Wildlife Preserve that will be managed by Middlesex County. After completion, this property will be one of the most beautiful open spaces and among the most walkable, hikable and bikable in the region. The site will include a public entrance and parking area with bike racks, which will be particularly useful once the future extension of the Middlesex County Greenway is complete. The project is expected to be completed by summer 2025.

Winter sports season is upon us and the Borough has once again constructed Charles Arena in the Charles Field parking lot for the 2024 Metuchen Floor Hockey League season. This outdoor pop-up street hockey rink was originally conceived by a dedicated group of local dads to keep the kids playing during the pandemic. We since realized that the outdoor rink significantly expanded the number of kids who were able to participate in what is now one of the most popular youth sports programs in the Borough.

We are very excited by the pending completion of the Edgar Field project, which should be complete within the next few weeks. In addition to serving as a field and an outdoor gym for Edgar Middle School students, it will be a transformative space for our entire community - changing it from a underutilized park to a recreational hub that both enhances the neighborhood and cements the school's role as a community hub. The project features new turf fields for full-sided soccer, youth soccer, baseball, softball and field hockey. Additionally, mark outs on the full soccer field will be made for lacrosse. Like Myrtle Field and Charles Field, Edgar Field also has a pedestrian walking path around its perimeter. Plans are underway for an exciting opening ceremony in April. The Edgar Field project will significantly expand the number of recreational opportunities for our community and we anticipate that we will be able to enjoy it on almost every day of the year.

And there are even more plans for recreational improvements in the year ahead. Last June, we announced that we have received funding from Middlesex Water to help improve Harold C. Junker Kiwanis Park (commonly known as "Center Street Park"). Junker Park has long been a neighborhood favorite in the "Radio" district, known for its slide on the hill, which had to be removed for safety reasons but will, of course, be replaced. We are excited that future generations of residents will be able to enjoy Junker/Center Street Park in the same way that so many others have over the years.

Also, we are excited to announce that, with the help of Middlesex County, plans are underway for a substantial enhancement of Trailhead Park. In its current form, Trailhead essentially serves as a parking lot for the start of the Greenway but the County's investment will be transformative. Plans call for an attractive passive recreation space that will include a Great Lawn-type concept in addition to a nontraditional play space that incorporates adventure and exploration features, as well as improved parking, restrooms, and significant landscaping enhancements. We hope to be able to announce more specific details for Trailhead Park in the next few months.

Conclusion

The first time I gave my new year's day message from this chair, it was January 1, 2018. I had just become Mayor just two weeks earlier and I described that "[p]eople choose to live in Metuchen because they want to be a part of a community that makes them feel welcome and valued but, perhaps most importantly, people live here because they feel their involvement and input matter." I explained that "[d]uring my time as a resident, I have learned that this is a town of teamwork. A place where our true magnificence is measured by the sum of all of our parts." I am so proud to say that this statement is as true today as it was six years ago.

Our efforts in Metuchen are successful because we have decided that our bold, collective approach makes a difference. Our volunteers, Borough staff, elected officials, and everyday residents who provide their candid feedback, in conjunction with County, State and federal officials, have propelled Metuchen forward. This is deliberate, and it will continue as long we continue to row in the same direction.

RESOLUTION 2024-01

RESOLUTION ADOPTING RULES AND REGULATIONS OF THE METUCHEN BOROUGH COUNCIL FOR 2024

BE IT RESOLVED by the Mayor and Council of the Borough of Metuchen that the following Rules and Regulations be and the same are hereby adopted as the rules and regulations of the Council for the year **2024** to continue in full force and effect until altered, amended, or made void by appropriate action of the Council.

RULE ONE

Regular meetings of the Council shall be held in the Borough Hall on Mondays of each month, or as otherwise noted, at the hour of seven thirty (7:30) p.m. provided, however, that in the event any such meeting shall fall due upon a legal holiday, then such regular meeting shall be held on the Tuesday following such legal holiday to be held at Borough Hall.

Special meetings shall be called and held as provided for by statute, and upon written notice, designating the time and place of meeting, signed by the Mayor or by four members of the Council, which notice shall be given to all members of the Council personally or left at their place of residence at least forty-eight (48) hours before the time of the meeting. Emergency meetings as provided in Open Public Meetings Act may be called on such notice as required by law.

Adjourned meetings shall be called to order and held at the time and place appointed by the motion or resolution under which it is held.

Agenda meetings of the Council shall be held at Borough Hall at the beginning of each regularly scheduled meeting of the Council. If agenda meetings fall upon a legal holiday,

then such agenda meeting shall be held on the Tuesday following such legal holiday to be held at Borough Hall. The meeting shall begin at 7:30 p.m.

RULE TWO

The Mayor shall preside at all meetings; in their absence the President of the Council shall preside; and in their absence, the senior member of the Council shall preside.

RULE THREE

The order of business at regular meetings shall be as follows:

- 1. Announcement of compliance with the Open Public Meetings Act, Invocation, Pledge of Allegiance and Roll Call
- 2. Agenda Session
- 3. Comments from the Public
- 4 Proclamations or Resolutions Honoring
- 5. Approval of Minutes
- 6. Public Hearings and Action on Ordinances
- 7. Introductions and Action on Ordinances
- 8. Communications Consent Agenda
- 9. Other Communications
- 10. Report of Officers
- 11. Report of the Borough Administrator
- 12. Report of Borough Council Members
- 13. Report of the Mayor
- 14. New Business Consent Agenda
- 15. Other New Business
- 16. Adjournment

RULE FOUR

The order of business for agenda meetings shall be generally as follows:

- 1. Announcement of compliance with the Open Public Meetings Act and Roll Call
- 2. Items for the regular agenda meeting
- 3. Reports of Council members
- 4. Report of Mayor
- 5. Reports of other Borough Officials
- 6. Meetings with any other persons or bodies
- 7. Any other business including items from which public may be excluded under Open Public Meetings Act
- 8. Adjournment

RULE FIVE

Every ordinance and resolution submitted for the consideration of Council shall be in writing. Every ordinance so submitted, including amendments to existing ordinances, shall be accompanied by a brief interpretive statement explaining the purpose of the ordinance or amendments. Any amendments to existing ordinances shall be provided in "redline" format when necessary showing the original text, along with proposed changes. No ordinance, or amendment to existing ordinance, shall be introduced unless a copy thereof is made available to each Councilmember no later than three days prior to the meeting at which the ordinance shall be introduced. The Council shall not be asked to consent to the appointment of officers of the Borough or members of Advisory Boards, Commissions and Committees, unless the name of the nominee for appointment is made known to each Councilmember no later than three days prior to the meeting at which consent shall be asked. The Council President shall be notified of all items on the agenda.

RULE SIX

A. In General

Since no substantive action will ordinarily be taken at agenda meetings, the only votes contemplated at such meetings are those to determine whether a matter will be placed on the agenda for the regular meeting, any points of order, and motions in respect to adjournment. Such votes shall be by a majority of members present, with the presiding officer voting only in case of a tie. However, nothing herein shall preclude the Council to adopt resolutions at agenda meetings to act on matters from which the public may be excluded pursuant to Sections 7 and 8 of the Open Public Meetings Act, or to vote on holding emergency meetings pursuant to the requirements of said Act. Procedure at agenda meetings not specifically set forth herein shall be governed by the rules hereinafter applicable to regular meetings.

B. Consent Agenda

The Council may establish a Consent Agenda for any regular or special meeting. The consent agenda shall apply to communications, resolutions and motions but shall not apply to ordinances. The Consent Agenda may then be approved by motion, by majority vote, without the necessity of the Borough Clerk reading the title or the actual body of the communications, resolutions, and motions on the consent agenda. If at any time prior to the adoption of the consent agenda at the regular meeting or special meeting, any Councilmember objects to placing or the existence of an item on the consent agenda, the matter shall be promptly deleted from the consent agenda and shall be voted on separately.

RULE SEVEN

A quorum for all meetings shall consist of four Councilmembers, or the Mayor and three Councilmembers.

RULE EIGHT

The order of business of agenda meetings may be modified by a vote of the majority of Councilmembers present.

RULE NINE

The Borough Clerk is directed to take the minutes of all meetings, which shall be distributed to all Council members.

<u>RULE TEN</u>

When a question is under debate, no motion shall be in order unless for recess, to lay on the table, to call the previous question, to postpone, to refer, or to amend, and these shall be precedence in the order in which they are named, the first three of which shall be decided without debate. A motion to refer, until it is decided, shall preclude all amendments for the main question.

RULE ELEVEN

The ayes and nays may be called by a member, and being called, the names of those who voted for or against the question, or abstained, if requested by any member, shall be entered in the minutes.

RULE TWELVE

When a member intends to speak upon a question, they shall acknowledge the chair only in their opening remarks; thenceforth they shall confine themself to the question and avoid personalities. Should more than one member rise to speak at the same time, the presiding officer shall determine who is entitled to the floor.

RULE THIRTEEN

The previous question may be called for by any member, and if seconded, shall be put in this form, "Shall the main question be put?", and until it is decided, shall preclude all amendments to the main question and all further debate.

RULE FOURTEEN

Any member may call another to order while speaking when the debate shall be suspended, and the member shall not speak until the point of order is determined. When the appeal from the decision of the chair is called for, no other question but the point of appeal shall be debated, when the question shall be put, "Shall the decision of the chair be sustained?"

RULE FIFTEEN

When any question is stated, and by Council agreed to be put, no member shall be at liberty to withhold their vote without the consent of the Council.

RULE SIXTEEN

A motion to adjourn shall always be in order and decided without debate.

RULE SEVENTEEN

The proceedings of the Council where not specifically mentioned herein, shall be governed by <u>Robert's Rules of Order</u>.

RULE EIGHTEEN

Except as otherwise provided by law, all action of the Council, including the passage of ordinances, resolutions, creations of committees and the appointments or consent to the appointments of any officers of the Borough or members of advisory boards, commissions or committees, shall be by a majority vote of those members of the Council present.

RULE NINETEEN

Except as otherwise provided by law or specific rule, the Mayor shall appoint the Chair of all committees. It shall be the Chair's duty to give notice of the time and place of meetings for the purpose of preparing the business for which they are appointed.

RULE TWENTY

The names of members of the Council, when called by the Clerk on any questions, shall be called alphabetically, with the Presiding Officer's name called last. Reports of Councilmembers shall be given in reverse alphabetically by order except that the Council President shall be first.

RULE TWENTY-ONE

All bills shall be itemized and certified to by the claimant as being correct, just, and true. Before any bills shall be presented to the Council for payment, it shall have first been certified by the officer incurring the indebtedness. Before payment all vouchers must be approved and signed by the Administrator.

RULE TWENTY-TWO

No rule of this Council or part thereof shall be amended, suspended, or superseded without at least the consent of two-thirds of the entire Council, except as provided in Rule Seven.

RULE TWENTY-THREE

All rules of the Borough Council heretofore adopted and inconsistent herewith are and the same are hereby repealed.

RULE TWENTY-FOUR

The Presiding Officer at the commencement of every meeting shall announce publicly and shall cause to be entered in the minutes of the meeting an accurate statement that adequate notice had been given to the public of the time, place of the meeting, and the manner in which said notice was given, Section 5 of the Open Public Meetings Act.

RULE TWENTY-FIVE

The Borough Clerk shall be the Borough official responsible for posting, mailing, and filing of the "Adequate Notice" of meetings as provided in the Open Public Meetings Act including an annual schedule of meetings and any revisions thereof as set forth in Section 13 of said act.

RULE TWENTY-SIX

The Borough Clerk shall be the Borough official responsible for making minutes of Council meetings available to the public pursuant to Section 9 of the Open Public Meetings Act, and the mailing of regular meeting schedules or revisions thereof to persons requesting same under Paragraph 14 of said act.

RULE TWENTY-SEVEN

Public comment shall be afforded all members of the general public at each regular and special meeting of the Mayor and Borough Council. Any member of the general public desiring to address the governing body shall do so upon recognition of said speaker by the Mayor or Presiding Officer. The speaker shall first identify themself by name and address. The speaker shall be permitted to address the governing body on any topic that is for the good and welfare of the general public. Public comments, questions, or other reasons for an appearance at the meeting shall be limited to five (5) minutes per speaker. Persons making public comments are not permitted to yield their allotted time to another individual. No questioning of individual members of Council shall be permitted by any speaker. In the event a speaker wished to pose a question to any individual member, they shall address the question to the Mayor or Presiding Officer, the time limitation imposed by this Rule may be waived or modified by the Mayor or Presiding Officer or by a majority of the Council Members present, upon motion duly made and seconded. No member of the public shall be allowed to poll the council on any issue. The Mayor or the Presiding Officer shall on all occasions preserve the strictest order and decorum and shall cause the removal of all persons who interrupt the orderly proceedings of the Governing Body.
