**ORDINANCE AMENDING SECTION 169-3E OF THE CODE OF THE
BOROUGH OF METUCHEN ENTITLES “MEMBERSHIP AND FEES”**

NOW THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of Metuchen that § 169-3E of the Code of the Borough of Metuchen is hereby amended and supplemented to include a Couple Resident Membership, Couple Non-Resident Membership, Senior Couple Resident Membership and Senior Couple Non-Resident Membership to its memberships available for the Borough of Metuchen Pool; and

BE IT FURTHER ORDAINED by the Council of the Borough of Metuchen that § 169-3E of the Code of the Borough of Metuchen is also amended and supplemented to define a “Couple Resident Membership” as two (2) adults over 18 residing in the same Metuchen residence, “Couple Non-Resident Membership” as two (2) adults over 18 residing in the same residence located outside of Metuchen, “Resident Senior Couple” two (2) Metuchen residents each 62 years of age or older at the time of membership registration residing in the same Metuchen residence, and “Non-Resident Senior Couple” two (2) non-Metuchen residents each 62 years of age or older at the time of membership registration residing in the same residence located outside of Metuchen; and

BE IT FURTHER ORDAINED by the Council of the Borough of Metuchen that § 169-3E shall be amended to include the below rate additions and changes:

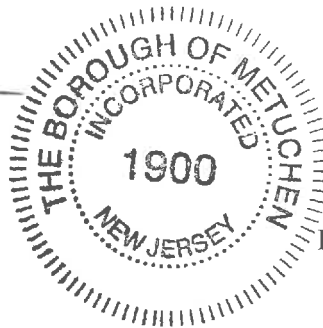




