organization by going in or upon private residences not having been requested or invited to

do so by the owner or occupant.

NO SOLICITATION WILL BE TOLERATED ON PRIVATE PROPERTY THAT HAS SIGNS STATING "NO SOLICITING".

Any person or persons interested in engaging in door-to-door canvassing or solicitations shall file with the

Borough Clerk the following:

1. A completed application.

Proof, if applicable, that the organization on behalf of which the "regulated activity" will be

conducted is a non-profit corporation and/or exempt from federal income taxation.

A letter or written statement from the individual, firm or corporation employing the

applicant, certifying that the applicant is authorized to act as the employer's representative in carrying out the

"regulated activity."

5. Two (2) Passport Photos
